- 1. THAT Administration undertake procurement by way of a Negotiated RFP (Concurrent Process) of a consultant to support Council in conducting the annual CAO Review, up to a maximum of \$35,000, with any balance exceeding the approved budget of \$9,500 to be funded from the Municipal Contingency Reserve (R2) if required.
- 2. THAT the following Consultant Deliverables be approved for inclusion in the Scope of Work for the CAO Annual Review RFP:
 - a. Quality check on the proposed questions to ensure clarity
 - b. Develop and administer an on-line survey tool to gather feedback from:
 - i. Council (9 members)
 - ii. Direct reports & Directors (25 individuals)
 - iii. Peers (up to 6 external)
 - iv. CAO (self-evaluation)
 - v. Gather qualitative feedback on strengths and areas to improve through appropriate open-ended questions
 - vi. Coordinate communication with participants
 - vii. Develop and facilitate Council consensus & validation process
 - viii. Provide a comprehensive report on the results to Council with materials to support communication with CAO
- 3. THAT the following Evaluation Criteria & Weighting be approved for inclusion in the CAO Annual Review RFP:
 - a. Initial evaluation
 - i. 15% Company Experience (municipal/public sector/CAO evaluation/360 on-line surveys)
 - ii. 20% Key personnel qualifications (who will be working with us and their related experience)
 - iii. 35% Proposed approach to the review
 - iv. 10% Schedule/timelines ability to deliver final report/discussion by the end of October
 - v. 20% Price (formula administered by Procurement Services)
 - b. Final evaluation (after interview)
 - i. 60% Interview
 - ii. 40% Price (formula administered by Procurement Services)
 - c. Reference check pass/fail (Procurement Services)
- 4. THAT Enclosure 2 be created and added to item 3.2 and remain private until the invitations to respond to the RFP have been issued; and
 - THAT the Consultants named in Enclosure 2, subject to any conflict of interest issues that may be identified, be invited to respond to the CAO Annual Review RFP.
- 5. THAT the June 7, 2018 Special Council meeting be cancelled.
