2012-2017 Capital Plan Nearing Completion

\$90 Million /13 Initiatives /18 Sites

- 9 new trail projects
- 7 new water access points
- 2 new pedestrian bridges
- 1 funicular in Edmonton
- 3 upgraded pedestrian bridges crossing Battery Creek
- 3 upgraded staging areas in Strathcona, Parkland, & Sturgeon County
- 1 community centre in Fort Saskatchewan
- 70 km of new trails
- 1/3 funding model



2018-2022 Phase II Capital Program


\$100M/Program approved by all municipalities

- 1/3 funding model w/ municipal, provincial, federal gov'ts
- Currently seeking funding commitment from provincial & federal gov'ts
- 5 -7 yr build out
- Continued emphasis on connectivity & access

- 4 pedestrian bridges, 3 boat docks, 5 trails
- 1 waterfront promenade

Edmonton & Strathcona County	Secondary Trail	\$1,020,000	Total: \$28,860,000
Edmonton & Strathcona County	Pedestrian Bridge	\$26,020,000*	*1/3 split between municipalities
Edmonton & Strathcona County	Boat Access	\$1,820,000	


