Recommended Option 1 Summary:

- Construct Stage 2C in 2018, which includes the curve at Range Road 224
- Fund all remaining land costs, and if required any design modifications for Stage 2B, to ensure shelf-ready plans can be created for a future business case for Stage 2B.
- Propose to construct Stage 2A and 2B under a future separate capital business case. Any construction costs related to re-design stemming from land process would be included in the future business case in the 2019 capital budget.

- Stage 2B (center section) construction costs will not be spent until the land acquisition process (possible expropriation) is complete, or further re-design to avoid the property is complete, which could be 1-2 years away. Stage 2B would be brought forward under a future business case in 2019 Capital budget.
