- Working with community partners to improve mental health supports for residents

- Starting next four-year recreation plans (2019-2022) and creating a 12-year strategy
- Constructing the Ardrossan Spray Park and area in 2018
- Planning for a new spray park on the east side of Sherwood Park in 2019
- Providing affordable recreation opportunities through programs such as Everybody Gets to Play™
- Achieving full certification through Accreditation Canada to ensure a high level of pre-hospital (EMS) patient care for residents.







- Managing impacts to emergency response and resource capacity
