Runway extension/rehabilitation

- Runway/taxiways paved 1983 resurfacing required
- Ideal time for runway extension
 - Enables slightly larger aircraft and commercial operators
 - Significantly increases airport economic contribution
- Costs to be shared with provincial government








Capex Recovery



Incremental cash flow to County




Other public benefits


