Re; Funding Request for Field Signage

This request is submitted by the Sherwood Park Rams Football Club ("the club"). The club is a non profit registered society having been incorporated in July, 1992 as part of file number 50533909. The club has been part of the County since 1962.

The club runs its practice facility from the Kinsmen Park location on Strathcona Drive. The club provides a safe sports environment for the sport of football for County youth aged 12-15 years.

In June 2017, County Council approved the name change of the former "Kinsmen Sports Field" located at Kinsmen Park in Sherwood Park to the "Jim Skitsko Sports Field" in honor of the long-time bantam football coach and County of Strathcona (Sherwood Park) resident.

On June 2, 2018, a ceremony will be held at the field to honor and dedicate this significant achievement to Coach Skitsko. During the discussions with the County officials, the club has learned that a protocol regarding the particulars of the sign must be followed. We have made inquiries of the cost of such a sign and have learned that the signage will cost approximately \$625 including GST. The estimate for the signage and particulars will be provided to you in the near future.

As you can appreciate, the club is a non profit society offering sports activities at a break even cost to the young athletes.

We hereby respectfully request that the cost of this signage be approved through the "Priority Fund Process" available to residents of the County. Upon receipt of the funds, a timely accounting will be provided to Council by our club treasurer.
