Letter of Request - Detailed use of funds

The Strathcona Youth Justice Committee (SYJC) has been working with the youth of Strathcona County since 1998. Our primary focus is to administer the extrajudicial sanctions program to the youth of Strathcona County. In doing so, the SYJC assists the youth in giving back to the community while at the same time provides them the opportunity to not incur a criminal record.

For the last year, the SYJC has faced several challenges that have ultimately set us back in our performance. There have been issues with recruitment, operations, finance and mismanagement. It was the decision of the Executive to suspend operations to work through the operational defects.

It was in the fall of 2017 that the Executive was able to piece together enough policy to open our doors for the youth in need of our program. There is still much to be done and it is for this reason we seek funding through Councils Priority Funds.

The SYJC is seeking funds for the paid Contractor to complete a Special Project, which would allow us to establish and develop a current and fully operational organization.

The funds would be used to achieve the following:

- Bylaw evaluation and development for effective governance
- Development of Board and Committee Operating Policies
- Restructure of the Board and Committee Organizational Structure
- Review and develop a formal and specific recruitment policy in conjunction with Stakeholders
- Create a data base for all possible current and future funding opportunities for easy access

The Strathcona Youth Justice Committee is seeking \$12,000 for the Special Project. It is estimated that the funds required will cover the cost to successfully and fully complete all the above-mentioned tasks within a 12-month timeframe.
