
Brief description of request

We are a community within the community of Sherwood Park, comprised of 58 units housing diverse individuals, with a number of our families receiving rent supplement. In partnership with the Robin Hood Association since our inception in 1992, four of our town houses provide independent living for residence with developmental disabilities.

To function as a housing cooperative all members contribute their time and skills to enrich and maintain the shared property. This results in pride in shared ownership of our homes, including our outdoor gathering places. Presently we have a playground area, a sport court and green spaces that provides social and physical activity for over one hundred children who presently live here.

Whether parents are gathered watching their children at the park or community members are getting together for potlucks and barbeques, picnic tables will provide a welcome gathering space.
