

## Strathcona County Priority Fund Policy (Review) - Continued

## **Report Purpose**

To provide Council with revisions to the Council Priority Fund Policy as requested.

## Recommendation

- 1. THAT motion 2018/315 and amendment 2018/317 be withdrawn.
- 2. THAT revised GOV-001-032 Council Priority Fund Policy, as set out in Enclosure 2 of the September 25, 2018 Legislative and Legal Services report, be approved.

## Motion on the Floor (2018/315)

THAT the revised GOV-001-032 Council Priority Fund Policy, as set out in Enclosure 2 of the September 11, 2018 Governance Advisory Committee report, be approved.

## Amendment on the Floor (2018/317)

THAT the motion be amended by adding the words: "with the deletion of the words 'equally among all members of Council' in section 16 and replaced with the words 'to General Revenue at the end of each term' in section 16, following the words "be approved".

### **Our Prioritized Strategic Goals**

Goal 1 - Build strong communities to support the diverse needs of residents

#### Report

In accordance with its mandate and Council direction, the Governance Advisory Committee (GAC) reviewed the Council Priority Fund policy and proposed a number of revisions to Council. Some of the GAC's recommendations arose from Council's decision to discontinue the Strathcona County Investment Program (SCIP), while other changes were aimed at improving the Council Priority Fund program or adding clarity to the policy.

At the May 8, 2018 Council meeting, Council received a GAC report with some proposed changes to the policy. While there was satisfaction with a number of the changes, there were a number of other revisions requested by Council and thus the policy was referred back to the Governance Advisory Committee.

At the September 11, 2018 Council meeting, Council reviewed further recommended changes from the GAC (i.e. the changes that were directed at the May 8, 2018 Council meeting). Overall, there was satisfaction with most of the proposed changes, but there was also concern with how surplus Council Priority Funding would be addressed at the end of a municipal term.

At the September 11, 2018 meeting, Council confirmed its desire to see surplus funding redistributed evenly to all members of Council on an annual basis; however, Council also expressed a desire to have policy mechanisms in place to ensure that during an election year in-coming Councillors would have access to some Priority Funding. Further, there was also direction to have surplus funds returned to General Revenue. Council ultimately referred the policy to Administration to make the necessary changes.

## **Council and Committee History**

Sept 11, 2018 THAT the main motion (2018/315) on the floor, along with the

amendment (2018/317) be referred back to Administration to provide wording that would allow for budgetary allocation of funds in a general municipal election year to allocate 75% of the approved funding for the pre-nomination day Council Priority Fund Expenditures, with any of this portion of the allocated funds remaining as at nomination day being returned to general revenue, and the balance of the 25% of approved funding being allocated for the post-Organizational Meeting Council

Priority Fund Expenditures for that year.

May 8, 2018 THAT policy GOV-032-030 Strathcona County Investment Program be

rescinded; and that the remaining 2018 funds for this program be reallocated to the Council Priority Fund Expenditures program evenly

among all members of Council.

May 8, 2018 THAT effective January 1, 2019, budgeted Council Priority Funds be

allocated evenly among all members of Council, except that the

Mayor's Office will be given \$5,000 prior to the equal allocation of the

remaining funds.

May 8, 2018 THAT policy GOV-001-032 be referred back to the Governance Advisory

Committee to review and revise in consideration of the comments

made by Council – to return to Council by Q3 2018.
