

Smoking Bylaw Municipal Comparators

Smoking Bylaws (all substances treated the same):

Municipality	Cannabis and Tobacco
Camrose <i>Draft</i>	No smoking within: <ul style="list-style-type: none"> • Any public place where the public is ordinarily invited or within 10m of the doorway; and • 10m of a playground, park, seasonal skating rink, skate park, sports field, water spray park, or toboggan hill. City Manager may designate discreet smoking areas on City property upon request from tenants.
Devon <i>Draft</i>	Amendment to Community Standards Bylaw includes cannabis, tobacco, smoking & vaping restrictions: <ul style="list-style-type: none"> • No smoking or vaping within five (5) metres from a doorway, window or air intake of a building or patio. • No smoking or vaping cannabis in a public place as defined by the bylaw. • Designated areas can be created if: <ul style="list-style-type: none"> ○ It is not placed within 5 meters of the doorway, window or air intake of a building or shelter; ○ It complies with all applicable provincial legislation; and ○ Access to any person under the age of 18 is prohibited. • Medical cannabis permitted under above restrictions and if a person can produce a medical document on demand.
Edmonton <i>Draft</i>	No smoking within: <ul style="list-style-type: none"> • 10m of doors, windows, air intakes, patios, and bus stops; • Parks with children's amenities (including off-leash areas); • Churchill Square; • Valley Zoo, Muttart Conservatory, John Janzen Centre; and City owned golf courses.

<p>Fort Saskatchewan <i>First reading Aug 28</i></p>	<p>All smoking is treated the same. This includes tobacco, cannabis, and vaporizers. Smoking in public places is only permitted in signed designated smoking areas. Landowners can determine where designated smoking areas will be located. Owners of residential properties can determine where to restrict smoking on their property. Smoking is not permitted within 10m of any window, door, or fresh air intake. Fines are in place to encourage compliance.</p>
<p>Okotoks <i>In effect</i></p>	<p>No smoking in designated public places, including:</p> <ul style="list-style-type: none"> • Municipal buildings and within 10m of entrances and exits; • Public buildings and within 5m of entrances and exits; • Workplaces and within 5m of entrances and exits; • Public sidewalks and within 10m of public sidewalks; • Public pathways and within 10m of public pathways; • Outdoor public events; • Outdoor public places; • Public transportation vehicle; and • Public transportation vehicle shelter. • No smoking within 10m of any child under the age of 18 not under your custody.
<p>Strathcona County <i>Draft</i></p>	<p>Prohibited everywhere except:</p> <ul style="list-style-type: none"> • Dog parks; • Golf courses; • Roadways/sidewalks; • Certain outdoor recreation areas; and • Previously exempt hotel rooms. <p>Setback from doors and air-intakes increased to 10m and expanded to include areas where children congregate.</p>
<p>Wood Buffalo <i>In effect</i></p>	<p>All smoking and vaping banned anywhere the public has access, including parks and public events.</p>

Calgary <i>Draft</i>	Recreational cannabis cannot be consumed in public. Medical cannabis can be consumed in public under the same rules as tobacco.	No changes
Leduc <i>Draft</i>	No smoking in public places, referring to any property which the public may have access to, whether publically or privately owned. Cannabis consumption will be permitted in private residences.	No changes
Lloydminster <i>In effect</i>	No smoking in public places.	No smoking in public places except: <ul style="list-style-type: none"> • Sidewalks; and • Designated areas.
Parkland County <i>Draft</i>	A person must not smoke, vape or consume cannabis in any Public Place. "Public Place" means any place, including privately or publicly owned or leased property, which the public reasonably has or is permitted to have access, whether on payment or otherwise.	No changes
St. Albert <i>In effect</i>	Recreational cannabis cannot be consumed in public. Medical cannabis can be consumed in public under the same rules as tobacco.	No changes
Stony Plain <i>Draft</i>	No smoking in public places.	No changes
Sylvan Lake <i>Draft</i>	Recreational cannabis cannot be consumed in public. Medical cannabis can be consumed in public under the same rules as tobacco.	No changes
