Winter Maintenance Policy Summary Normal service levels

Unforeseen climatic condition clause

- Added the clause to the Winter Maintenance Policy on June 25, 2013 to address large accumulations of snow in a short period of time.
- Operations are accelerated when snowfall exceeds a 17 cm amount in a 48 hour period.
- It has been activated two times since it was added to the policy:
 - December 2014
 - December 2-3, 2018

December 2018 snow event

 Snowfall began on December 2 with 24 cm accumulated by early December 3.

Resource summary

- County Resources
 - 14 truck plow/sanders
 - 10 graders
 - 6 loaders/blowers
 - 5 sidewalk machines
- Additional Contract Resources were called into support
 - 60 tri-dem end dumps
 - 16 graders
 - 5 loaders
 - 4 sidewalk machines
 - 4 tow trucks
 - 3 Dozers (Meltwater Operations)
- Support from other Departments
 - Fleet Services, Enforcement Services, Corporate Communications



Costs

- Urban P3 Approximately \$350,000
- Urban P4 Approximately \$835,000



Parking during snow clearing

- Snow Route Parking Ban was declared December
 3 at 12 pm (tickets were not issued until after the
 24 hour waiting period)
- Temporary No Parking signs were installed on residential streets 24 hours prior to clearing initiated
- Fines
 - Parking of vehicle that interferes with maintenance activities
 - \$250.00
 - Towed vehicles are moved to the nearest cleared roadway, no tow bill is issued





Resident inquiries

December 2-10:

- 379 phone calls
- 146 county connect inquiries

Topic areas:

- Positives
 - Removed snow quickly
 - > Able to get around

Concerns

- Not enough warning prior to towing
- Sign placement concerns
- Noise of working through the night
- > Trails were slow to be cleared



Operational challenges

- Due to the fast pace of snow clearing, not as many orange No Parking signs were installed prior to P4 residential snow removal.
- Trails and bus stops were behind due to staff resources required for snow route and residential clearing.
- Managing resident expectations for future snow events under normal policy.



Future considerations

• Increase Rural Service Level during unforeseen climatic conditions to have all rural roads complete within 5 days instead of 6 days.
