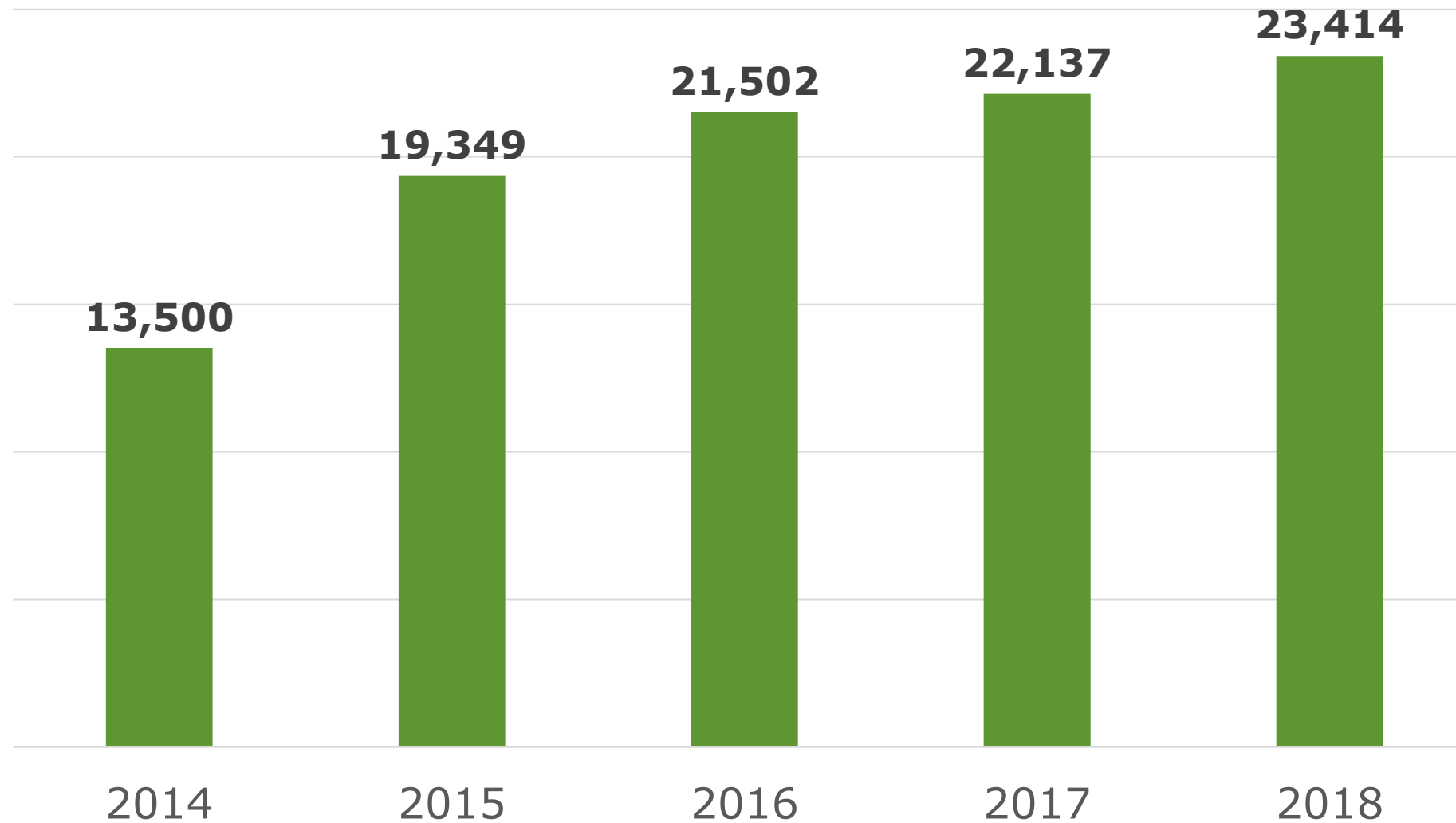

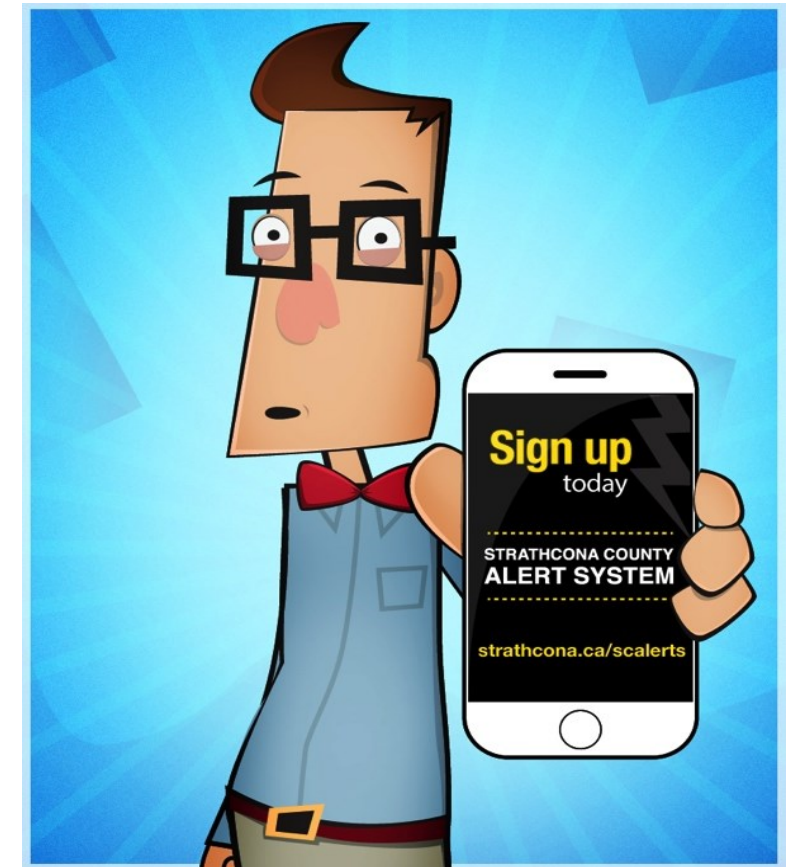


Strathcona County Alerts Registrations

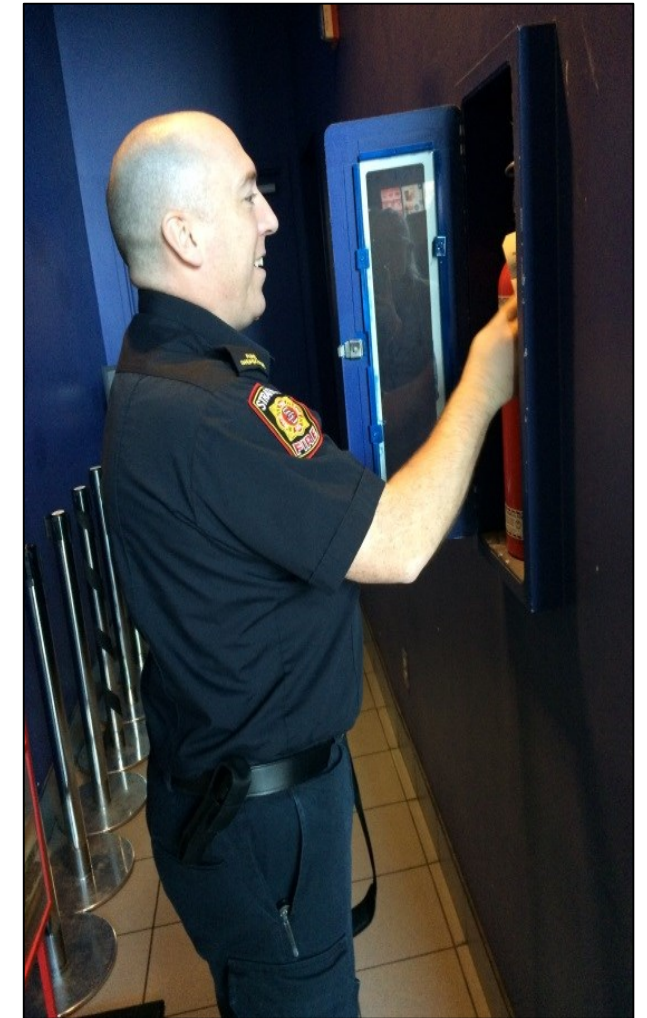

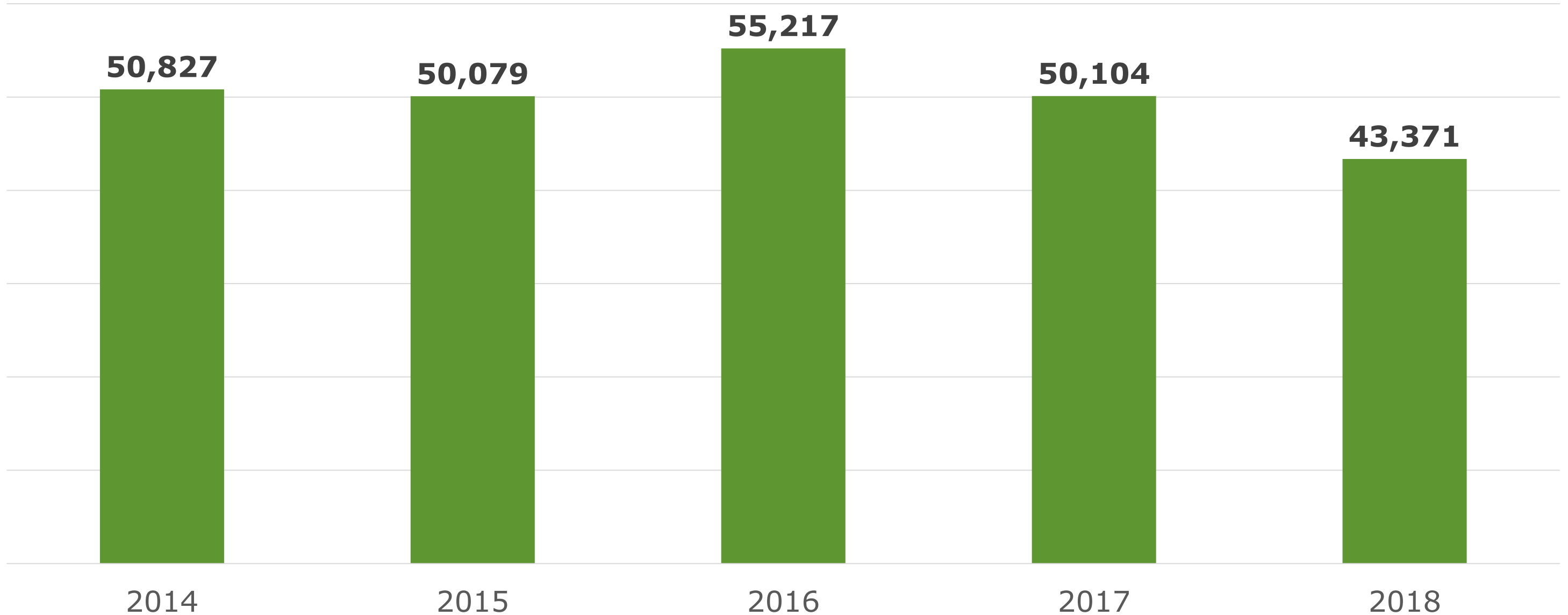

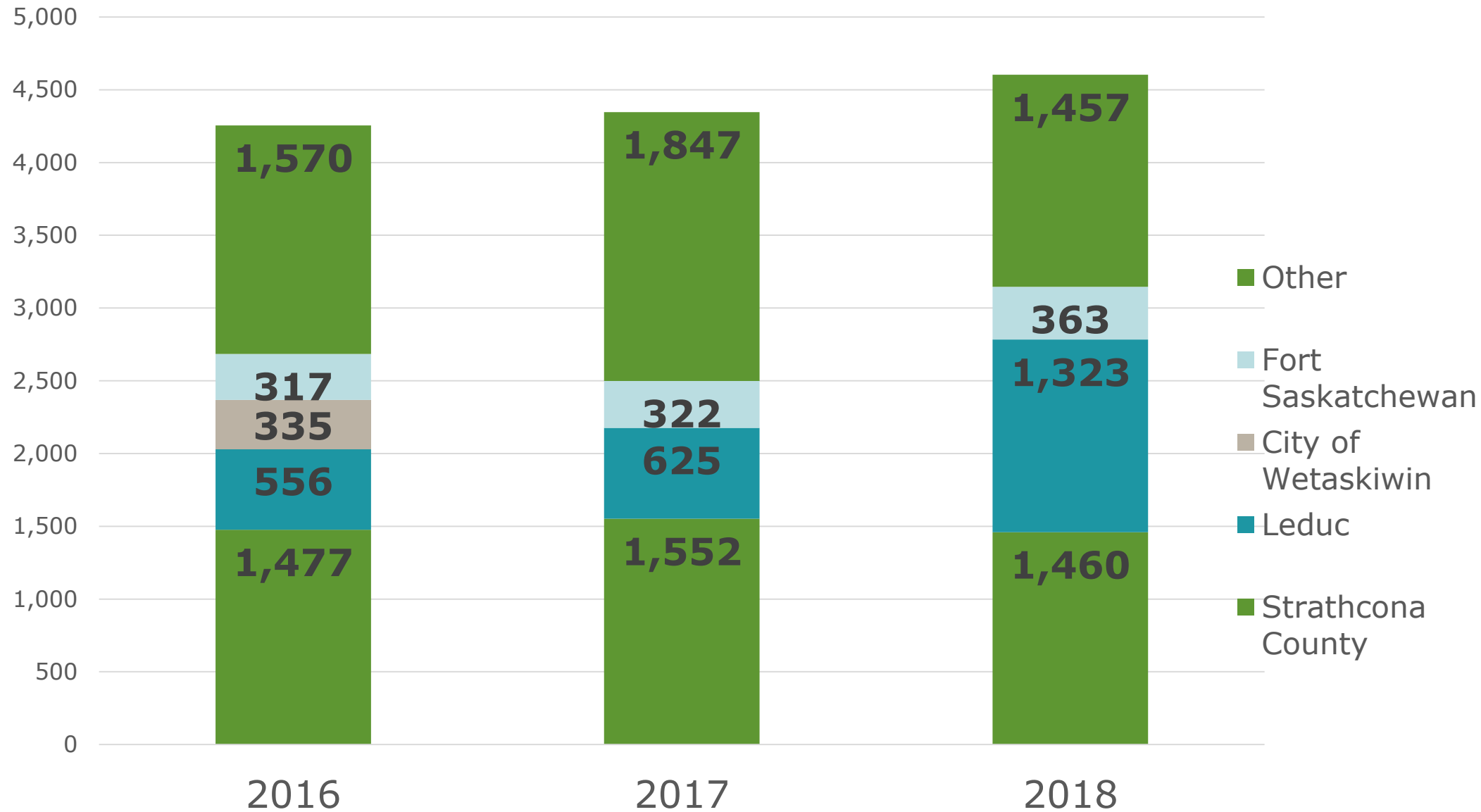

Total Events Dispatched



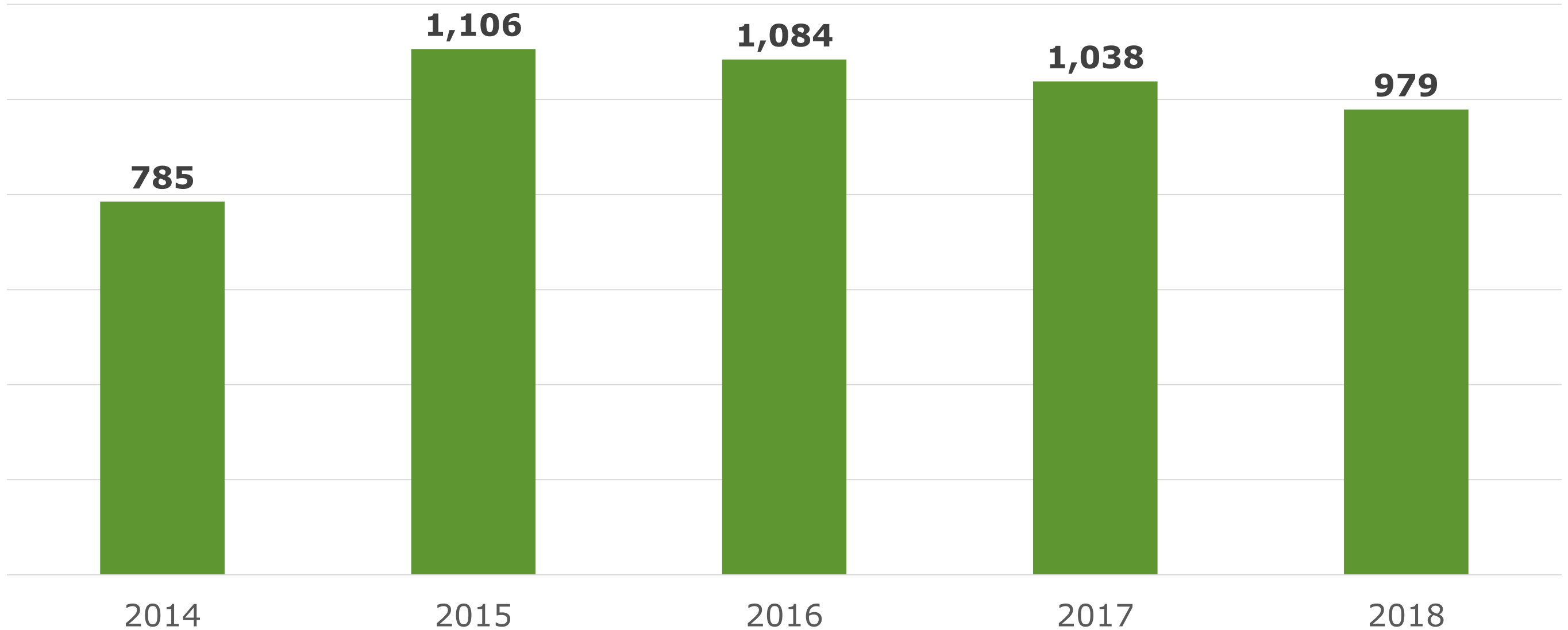

2017 to 2018

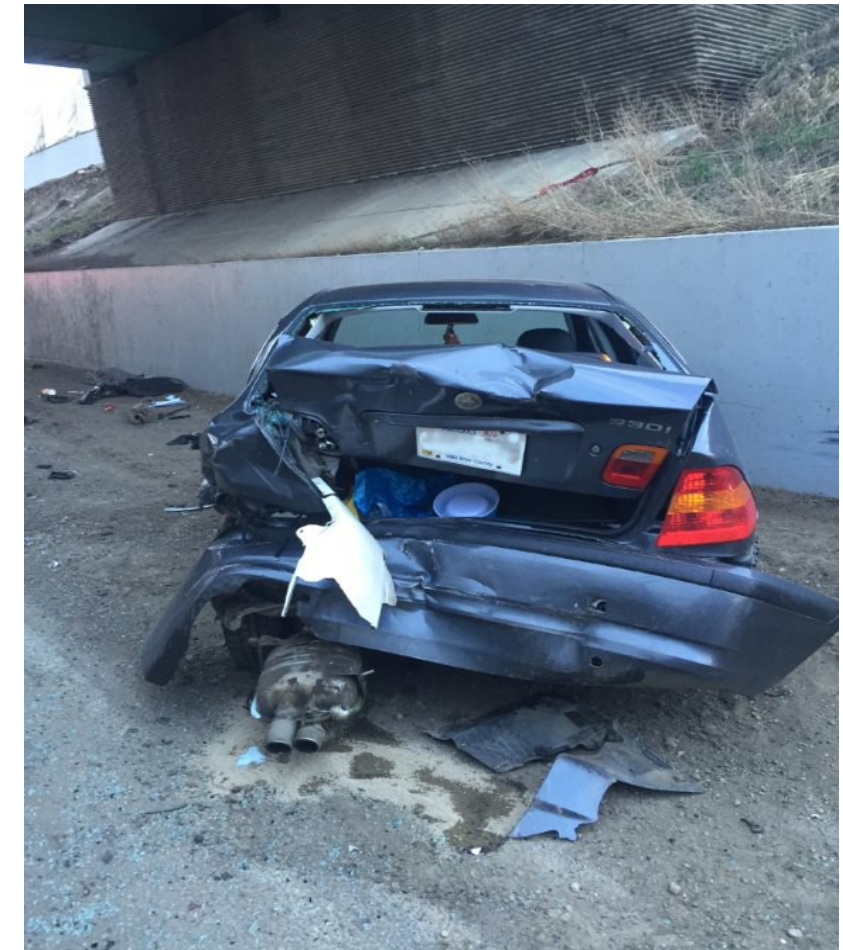
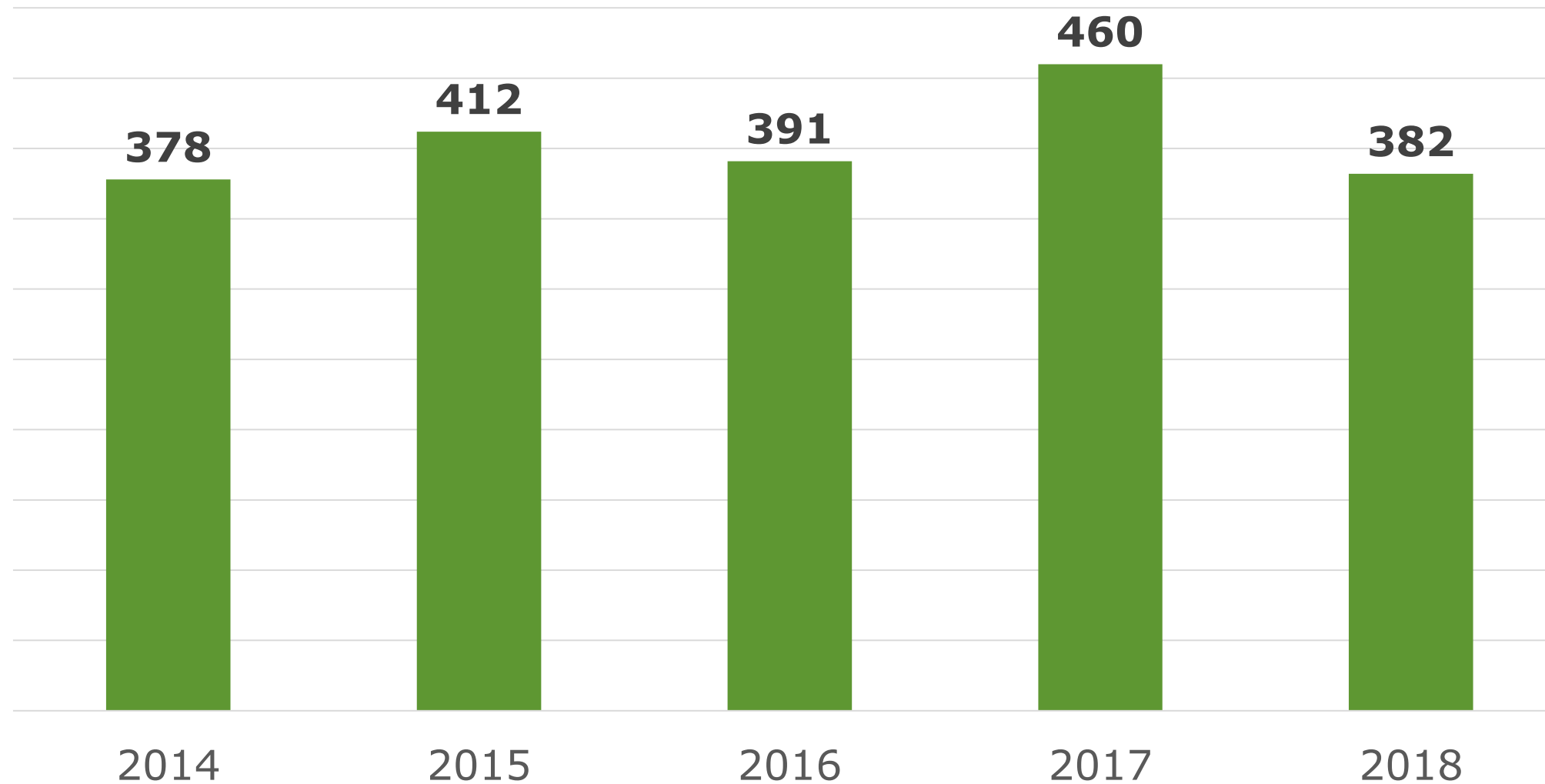
Fire Responses

Quality Management System

SCES Quality Management System (QMS) is certified through ISO:9001.

- In April 2018, SCES successfully transitioned to the ISO:9001 2015 standard, with zero findings by the auditor.

SCES is contractually required by AHS to hold industry-specific ambulance certification through Accreditation Canada.

- In October 2018, SCES successfully achieved Qmentum status with a compliance rate of 96%, resulting in a commendation.



SCES EMS Events

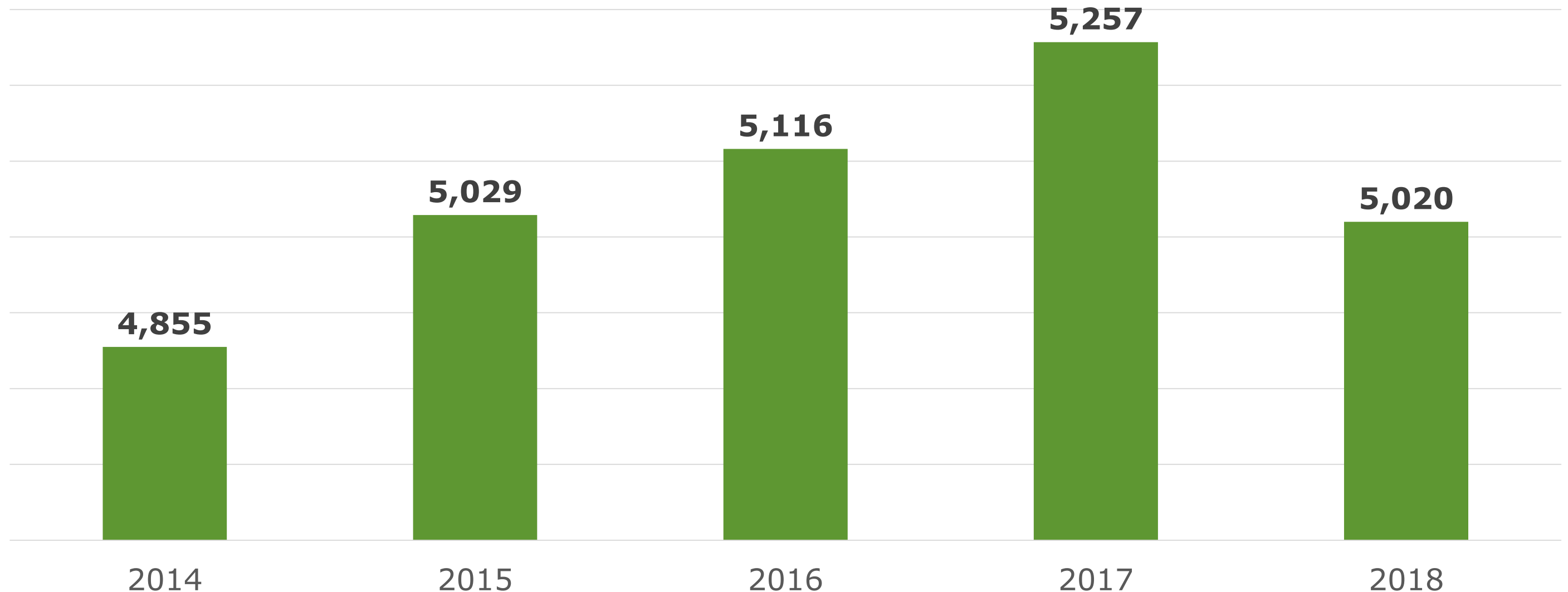
In 2018, there were 5,794 emergency events within Strathcona County.

SCES attended 4,533 of these events (78.2%).

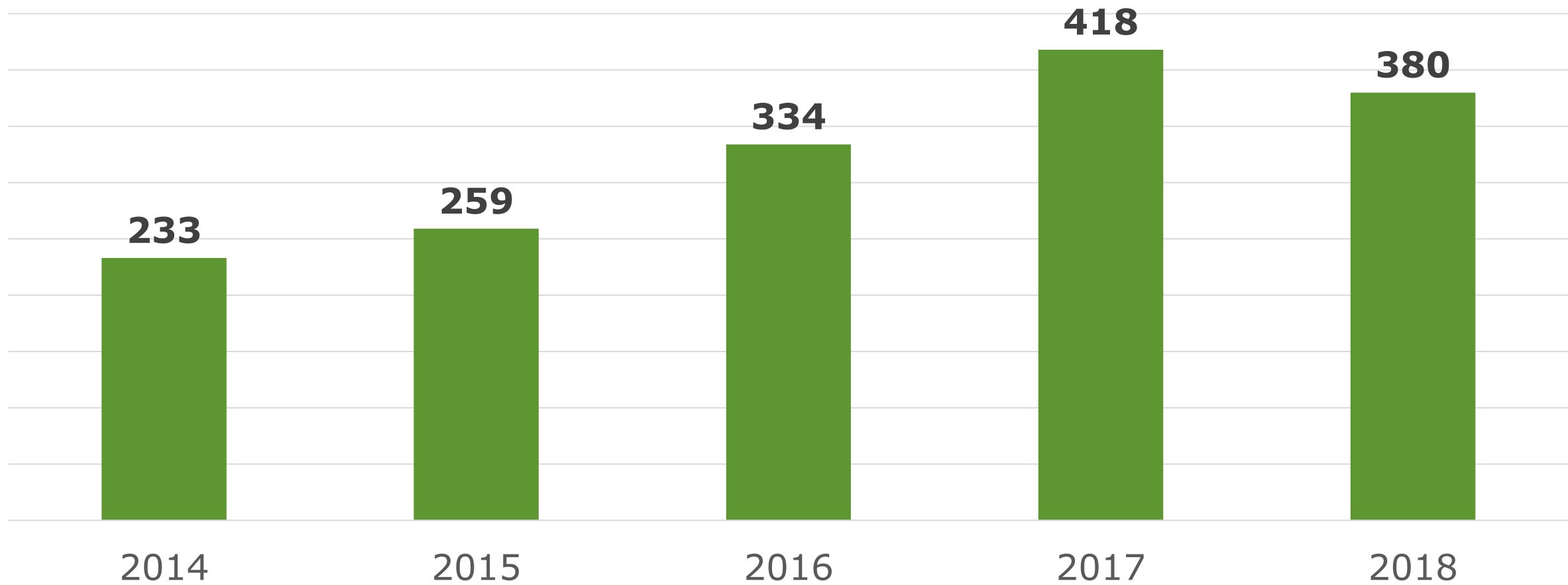


SCES EMS Events Within Strathcona County
