At tomorrow's PCM meeting (March 12, 2019), Council will be provided a high level overview of the draft 3 documents noted above as well as preliminary results of Phase 3 public engagement.

On April 10, 2019, the Financial Viability Analysis for Bremner will be finalized and available on our website for public review.

On April 16, 2019, the Financial Viability Analysis and final technical documents will be presented to Priorities Committee for discussion.

On May 14, 2019, Priorities Committee has been reserved to have additional discussions as needed.

On May 21, 2019, The Bremner and LEA Area Concept Plan will be presented to Council for Public Hearing and first reading. If given first reading, it will then be submitted to the Edmonton Metropolitan Region Board. If approved by the Edmonton Metropolitan Region Board, it would be brought back in July 2019 for second and third reading. The public hearing will provide an opportunity for members of the public to speak to Council on the proposed Area Concept Plan.
