

Revised Mandate Letters for the Accessibility, Seniors, and Youth Advisory Committees

Report Purpose

To seek Council approval of the revised mandate letters for various council committees.

Recommendation

Report

In the fall of 2018, Council established three new council committees: Seniors Advisory Committee, Youth Advisory Committee, and Accessibility Advisory Committee. The Council report providing the bylaws for the new committees also included the draft mandate letters for these new committees. Council wanted to see revisions made to the draft letters and referred the letters back to Administration for further work. Council also directed that Administration to work with the Governance Advisory Committee (GAC) and Priorities Committee on the letters.

Accordingly, the GAC provided input on possible revisions to the letters and the updated drafts were then presented to the Priorities Committee on January 29, 2019. The Priorities Committee did not request any further changes to the draft letters and thus they are now being presented to Council for formal approval and are provided as enclosure 1 of this report.

Recruitment for the new committees started on January 14, 2019 and the application period closes on February 22, 2019. It is expected that Council will consider appointments in March 2019 and that the first round of committee meetings will take place in the second quarter of 2019.
