# Strathcona County Design and **Construction Standards document**

- content developed by multiple departments in consultation with industry experts
- used by internal and external parties
- applies to design and construction projects in Strathcona County
- ensures safe and consistent practices



# **Previous updates**

- previously four separate documents:
  - Urban Service Area (last updated 2005)
  - Open Space Development Standards (last updated 2006)
  - Rural Service Area (last updated 2007)
  - Standard Form Construction Documents (last updated 2008)
- 2011: updates and amalgamation to form Design and Construction **Standards**
- 2015: updates to Wastewater Collection and Water Distribution System requirements (Volume 1, Sections 4.2 and 4.3)



# **Proposed update**

- changes to roadway design and construction methods since last update
- updates maintain continuity for former Urban Services Area and incorporate modern practices
- thorough review of multiple sections, collaboration with internal departments, and consultation with third-party utilities
- worked with the Urban Development Institute (UDI), received full support
