

Environmental Scan Background

Statistical Profile

 Yardstick developed a statistical profile of youth and young adults in Strathcona County and comparison communities, including St. Albert and adjacent Sturgeon County, Red Deer and surrounding Red Deer County, and Alberta more broadly.

Literature Review and Online Scan

• The scan was completed to evaluate the community needs of resident youth and young adults to highlight opportunities to help them thrive in Strathcona County.



Environmental Scan Main Findings

Statistical Profile

• Youth and young adults have a similar statistical profile to comparison communities with exceptions in a few areas.

Literature Review and Online Scan

Revealed opportunities for more unprogrammed space to engage youth and young adults.

Services Review

- The services database was updated with the following:
 - Review and update of pre-existing inventory provided by Strathcona County.
 - Inclusion of service providers and programs located within Strathcona County, Edmonton, Fort Saskatchewan, Key Provincial Services.
 - Targeted research to ensure the database included information related to Indigenous and other ethno-cultural groups, rural populations, as well as gender diverse youth and young adults, where possible.



Public Engagement: Phase 1

Audiences

- A multi-faceted approach is being used to target the following audiences in Strathcona County:
 - Youth and young adults ages 14 to 29
 - Parents of youth and young adults ages 14 to 29
 - Agencies and service providers delivering services/programming to youth/young adults

Methods

- Online Surveys
- Intercept Engagement
- Engagement in urban and rural settings

- Final report, including policy recommendations
