At the July 23, 2019 Council meeting, Council passed a series of motions to retire three advisory committees that have each achieved their original mandate. Following this decision, administration worked with the Mayor's office and contacted all of the members on the three committees. Committee members were thanked for their efforts and work as well as encouraged to apply for other committee opportunities. Reaction was fairly positive.

Council also directed administration to bring forward a report in the first quarter of 2020 that outlines the options and benefits of using task forces as a way of engaging with the public on specific policy matters. This report is in progress and will be brought forward by the assigned deadline.
