STRATEGIC INITIATIVE AND UPDATE

Bylaw 36-2013 Removal of Snow and Ice from Sidewalks within the Countyproposed amendments

Report Purpose

To provide the Priorities Committee information to consider amendments to the current sidewalk clearing bylaw.

Our Prioritized Strategic Goals

Goal 9 - Continuously improving the way we work, as one organization, in an agile and sustainable manner

Report

Council directed administration to look at options and costs with respect to the feasibility of requiring owners to clear sidewalks within 48 hours, and the feasibility of the County assuming responsibility for clearing side yards on roadways.

The report gives Transportation and Agriculture Services an opportunity to share with Priorities Committee options and impacts of possible amendments to Bylaw 36-2013 – Removal of Snow and Ice from Sidewalks within the County, the report includes:

- Feasibility of requiring that owners must clear sidewalks within 48 hours:
 - A review of neighboring municipalities shows a variation in residents' requirements and timelines to address snow and ice adjacent to their homes, though the goal remains the same which is to ensure safe pedestrian travel.
 - Currently owners of a parcel in the urban service area are responsible to remove all snow and ice from any sidewalk along the frontage and/or side of the parcel within eight days following the initial snow accumulation with a penalty including cost of remedial work plus 50% administrative fee.
 - With this expectation between 2016 and 2019 we note:
 - 173 County Connect cases
 - 254 Sidewalk inspections
 - 150 Reminder letters
 - 14 48-hour notices
 - 5 Reactive enforcements
 - Cost to clear all priority levels within 48 hours if we wanted to meet the same service levels on county-maintained trails would be \$1,425,000 and would require 24-hour clearing operations on the total network to meet the same service level as residents-maintained sidewalks.
- Feasibility of the County assuming responsibility for clearing sidewalks on side yards on roadways:
 - o Currently Strathcona County does not clear side yards
 - To provide this level of service, increased costs would be:
 - Additional cost to clear side yard walkways adjacent to collector roadways (6.11 kilometres) after completion of other service levels \$132,393
 - Additional cost to clear side yard walkways adjacent to residential roadways (13.98 kilometres) after completion of other service levels \$377,848
