Report

On July 17, 2018, Council approved a motion to sign onto the Memorandum of Understanding (MOU) to join the Regional Transit Services Commission (RTSC) work to develop the regulatory, technical, financial, and operational framework of a commission. Council then appointed Councillors Botterill and Anderson as the County's representatives on the RTSC Transition Team. On October 11, 2018, Mayor Frank, along with 12 other Mayors of the Edmonton Metropolitan Region, signed onto the MOU.

The inaugural meeting of the RTSC Transition Team was held on January 17, 2019. At the Transition Team's February 2019 meeting they selected EY (Ernst & Young) as the consultant to work with the Transition Team to complete Phase 2 – the establishment and transition phase of the Regional Commuter Service Phase Implementation Plan. A Working Team, comprising administrative representatives from the participating municipalities, was requested for information gathering and work plan development. Wade Coombs, Director, Transit, served on the Working Team for Strathcona County, with support from Nancy Lyzaniwski, Manager, Intergovernmental Affairs.

Overall, the project was broken into two stages. The first stage was to gather and catalogue all existing current information sources, and to develop the scope of work and detail a project plan for the second stage. The purpose of stage two was to execute on the scope of work and ultimately create the RTSC master plan (operational framework), meeting relevant requirements for a successful submission under the MGA regulation to form a regional services commission. Stage one was completed in April 2019 and stage two was completed on November 29, 2019. Council has received several closed session updates on the progress of the work over the past year.

On January 28, 2020 Priorities Committee received a presentation from the RTSC consultant EY on the final report, Accelerating Transit in the Edmonton Metropolitan Region: Building a Regional Transit Services Commission. Administration will be providing a presentation outlining further considerations, based on questions from the January 28, 2020 Priorities Committee meeting, that Council may want to consider before making their decision to join or not join the RTSC.



Council and Committee History

January 28, 2020 Council received a presentation on the final report for the RTSC, Accelerating Transit in the Edmonton Metropolitan Region: Building a Regional Transit Services Commission.

- July 17, 2018 Council approved the following: THAT the Mayor, on behalf of Council, sign the Memorandum of Understanding for the Regional Commuter Service Phase Implementation Plan; and

THAT Councillor Botterill and Councillor Anderson be appointed as the Elected Representatives for Strathcona County to the Regional Transit Transition Team, both terms to commence effective as of the signing of the Memorandum of Understanding and ending at the sooner of the 2019 Council Organizational Meeting or the creation of the Regional Transit Services Commission by provincial regulation, and provided that the appointees continue to serve as Councillors throughout the terms of appointment.

- January 23, 2018 Council received an update on the discussions taking place between the cities of Edmonton and St. Albert.
- September 9, 2014 Council formally endorsed Administration's response to the Capital Region Board regarding the Inter-Municipal Transit Study.
