4.1 Alberta Emergency Management Act (2018)

The Committee received a presentation on Emergency Management definitions, priorities, responsibilities, and the powers granted under the Alberta Emergency Management Act (EM Act) when a State of Local Emergency (SOLE) is declared.

4.2 Local Authority Emergency Management Regulations (2018)

The Committee received a presentation on the 2019 Emergency Management Audit (conducted by the Alberta Emergency Management Agency (AEMA)) with focus on the Strathcona County Emergency Management Bylaw 17-2018, and the alignment with the Local Authority Emergency Management Regulations (LAEMR).

The Committee reviewed the role of the Strathcona County Emergency Management Agency (SCEMA), and the responsibilities of the Emergency Operations Centre (EOC) in planning and managing community recovery.

The Committee received a presentation on the current Municipal Emergency Plan (MEP) and discussed an updated plan to come forward in the fall of 2020.
