##### **Report**

Transportation and Agriculture Services mission is to "Inspire community by enabling safe travel and agriculture". The department is committed to supporting our residents and other levels of government through the delivery of programs and services in the areas of Public Works, Winter Maintenance, Right-of-Way Management and Agriculture. Across all department programs, we provide the essential infrastructure and services that contribute to a high standard of quality of life for residents throughout urban and rural Strathcona County. Enabling safe travel speaks to the function of the department to ensure residents can move safely throughout out network of roads and walkways in every season. The work we do to enable agriculture involves the protection of soil and water, pest and vegetation control, along with education and awareness to ensure a strong rural community lifestyle.
