Report

The Strathcona County Emergency Management Agency (SCEMA) will provide a situation update on Stage 2 of the Alberta Government Relaunch Strategy which took effect on June 12, 2020. SCEMA, under the direction of the lead public health agency Alberta Health Services (ASH) will provide plans and efforts being aligned in response including information on staffing, implementation of controls at facilities, re-opening of recreation centres, and community supports.

SCEMA continues to plan and prepare as we move through the stages of the provincial strategy. It is important that our response continue to be consistent with provincial direction, is operationally feasible, and ensures the safety and viability of our residents, staff and community.
