#### Report

Family and Community Services has a mission to provide stewardship of the Social Framework in our community to create together a supported, safe and connected community for all. The department focuses on holistic, evidence-based, action-oriented supports and skill-building within the mandate of prevention and early intervention, while leveraging community partners' areas of expertise. The department has two related core business functions, Empowering Individuals and Families and Empowering Communities. The next year will see continued development and strengthening of partnerships across sectors.

## Empowering Individuals and Families: 2020-2021 Forecast

Staff teams provide a holistic, responsive, evidence-based continuum of supports and skill building strategies to children, youth, adults, seniors and families. Teams collaborate with participants and partners to empower individuals through seamless support and connection with the wider community. In response to changes in priorities and funding by the Government of Alberta in its approach to prevention and early intervention services for children, youth and families throughout the province, Family and Community Services is leading and evolving service delivery to align with changing provincial priorities, while continuing to support community through implementation of the Social Framework. Over the coming year, data and experience will be used to refine service delivery in alignment with local and provincial priorities as the department and partners learn and explore new and evolving roles across the following programs:

- Family Resource Network
- Counselling
- Mental Health Capacity Building
- Solutions Navigation
- Home Support
