Governance Requirement

Report

At the July 14, 2020 meeting, Council gave direction to amend Bylaw 17-2020 to address procedures related to the response to the Covid-19 pandemic. The procedural changes introduced in Bylaw 17-2020 were required to ensure that physical distancing measures could be included in public hearings and other public presentations. The change in procedures was made possible because the Government of Alberta provided a regulation that allowed for departure from certain *Municipal Government Act* requirements related to meetings and public participation.

Since the pandemic situation is evolving and the County can now allow some public inperson attendance in Council Chamber for meetings, it is desirable to amend Bylaw 17-2020 to allow for an in-person option for public hearings and other public presentations.

The proposed bylaw is provided as enclosure 1 and, should Council give the bylaw three readings, it will take effect by August 1, 2020 and will apply to any upcoming public hearings from that time forward. Finally, it should be noted that Bylaw 17-2020 and any amending bylaws are only in place as long as the provincial Regulation is in force.
