# Teen braves cold to earn money for first car

The extreme cold snap didn't stop one Sherwood Park teen from her goal of shovelling sidewalks and driveways to raise money to buy her first car.

Devan Besserer, 16, was likely one of the few people in the area who were outside voluntarily during the coldest week of the year as she cleared snow and collected money towards her goal.

"My sister and I started shovelling last year but I started doing it more this winter in November to save up," explained Besserer said.

The Bev Facey Community High student is getting ready to take her driver's training course this month and plans to take her driver's test by the end of February.

As she prepares for life behind the wheel, the student wanted to get her own set of wheels and has been squirreling away money whenever possible. She said when the extreme cold hit, it was a perfect time to offer her snow shovelling services.

"I knew that if it was cold enough outside that I could help people around me because nobody would want to shovel," she said. "The coldest I shovelled in was probably around -40 with the wind-chill."

With those bitterly frigid temperatures, Besserer bundled up with lots of layers.

"When I was out in the cold I put on four pairs of pants, eight pairs of socks, I wore a turtleneck, a long sleeve, three crew necks, a hoody, my jacket, a toque, a scarf, a balaclava, three pairs of mittens and ski goggles," Besserer detailed. "I was out for probably about three hours and went house to house. I ended up doing about four houses on the first day and on the second day I ended up doing five."



Besserer noted she provided services to about 10 houses altogether during the coldest days.

A resident who saw her shovelling even decided to shine the spotlight on her on the Summerwood Facebook Page by sharing her story. Besserer said that caused more people to reach out to her to get her to shovel their properties.

"I'm really thankful for the community for their help," Besserer noted. "It has been a big help in saving for a car."

The work will be worth it though, according to the 16-year-old, who is excited to be able to buy her first vehicle herself.

"I'm just looking for a used car that is automatic and can get me from point A to Point B," she said.

The driven entrepreneur plans to continue shovelling sidewalks and driveways until the end of winter to save up as much as she can. Paychecks from her job at Northern Reflections are also going towards the teen's major purchase.

"I've saved close to \$200 from shovelling and I have saved \$1,100 before I started shovelling." she said. "I'dlike to save around \$2,000 before I go to buy a car and by the end of winter I'm hoping to have enough."



# 2019 air quality results show improvement

In 2019, FAP found there were 177 hours of high or very high-risk ratings.

The group that monitors air quality over the Alberta's Industrial Heartland has released its report for last year, which showed residents breathed a little easier in 2019 due to increased air quality.

The Fort Air Partnership (FAP) 2019 Regional Air Quality Monitoring Results showed the continuous monitoring stations around the area and found the Air Quality Health Index (AQHI) Rating for the year was significantly lower than 2018.

We did see a big difference from 2018 to 2019. In 2018, we had a massive wildfire event that impacted all of Alberta for a good part of August and we did see a very high number of particulate matter that year that we didn't see in 2019," explained Nadine Blaney, executive director of the Fort Air Partnership. "We had one event at the end of May 2019, so we did see high numbers at that time but that was a three-day period and for the rest of summer it was quiet."

In 2019, there were 177 hours of high or very high-risk ratings, which was much lower than the 849 hours recorded in 2018.

'The Air Quality Health Index Ratings were in the low-risk category for the majority of the year, with less than half a per cent of the hours monitored being in the high or very high risk category," Blaney said.

2018's poor air quality could be attributed to wildfires that raged across the province and in British Columbia.

More than half of the 2019 high or very high-risk ratings were also caused by wildfire smoke that occurred in May and early June.

"When you look at the ambient air quality objectives that are in place for the province, the majority of those do come from wildfire smoke and that is really what impacts the AQHI throughout this region," Blaney said.

Overall, the region, which does not include Sherwood Park or Ardrossan, experienced low risk ratings on average of 94 per cent of the time, which was a six per cent improvement from 2018.

The majority of our high and very high risk readings come from wildfire smoke but there is also a number of them that occur during winter time temperature inversions, which is when there is a layer of cold air that traps warm air at ground level and the pollutants can't disburse, which leads to increased levels of particulate matter as well," she said. "We did see 60 out of 170 hours in the high or very high risk category that were due to temperature inversions that occurred during the winter.'

Fort Saskatchewan had the least amount of low risk readings in 2019, with low risk readings 90.7 per cent of the time. Lamont had the most low risk readings at 95.5 per cent.

Blaney noted the organization pleased with the 2019 results and hopes 2020 is similar or better.

There is no way of knowing at this point and it really does depend on the wildfires that occur in the summer. That is really the major impact on air quality in the region at this point," said the FAP executive director.
