The NHS prioritizes the social sector, housing that exceeds mandatory minimum requirements, and partnerships between governments, non-profits, co-operatives, academics, and the for-profit sector. 	 Provincial Update: In 2020, the province launched an Affordable Housing Review Panel with a mandate to analyze market trends and projections, compare approaches to housing in other provinces and consider supports for Albertans in critical housing need.
