

**Summerwood North Stages 5 and 6 park and road naming (Ward 4)****Report Purpose**

To provide information to Council to make a decision on proposed park and road names within Summerwood North Stages 5 and 6.

**Recommendations**

1. THAT the name "Sandstone Park" for the Summerwood North park, as set out in Enclosure 3 of the December 8, 2020 Planning and Development Services Report, be approved.
2. THAT the name "Sedum Park" for the Summerwood North park, as set out in Enclosure 3 of the December 8, 2020 Planning and Development Services Report, be approved.
3. THAT the name "Sedum Way" for the Summerwood North road, as set out in Enclosure 3 of the December 8, 2020 Planning and Development Services Report, be approved.
4. THAT the name "Sawara Way" for the Summerwood North road, as set out in Enclosure 3 of the December 8, 2020 Planning and Development Services Report, be approved.

Governance Requirement

**Report**

The developer of Summerwood North Stages 5 and 6 is proposing to name two parks and two roads.

The proposed name "Sandstone Park" is a park adjacent to Sandstone Boulevard and proposed to be developed with a community garden and trail connecting pedestrians from Sandstone Boulevard to Sunland Way.

The proposed name "Sawara Way" connects Sandstone Boulevard to Sunland Way. Sawara is from the name Sawara Cypress, a compact conifer forming a dense pyramid, evergreen shrub that has soft bright green fern-like branches.

The proposed name "Sedum Park" is for a park that will be developed to include a trail to connect Stage 5B to Sandstone Boulevard. The proposed name "Sedum Way" will connect at two points to Sandstone Boulevard and wrap around the southeast of Summerwood North southeast of the Syd Ottewell stormwater management facility. Sedum is a perennial plant with thick, succulent leaves, fleshy stems, and clusters of star-shaped flowers common throughout the Province of Alberta.

The names Sedum Park, Sedum Way, Sandstone Park and Sawara Way are consistent with the naming pattern established for the Summerwood neighbourhood and meet the requirements of the County's naming policy.

**Legislative/Legal:** The *Municipal Government Act* authorizes a municipality to name parks and roads within its boundaries.

**Interdepartmental:** The proposed park and road names for Summerwood North Stages 5 and 6 have been reviewed through the circulation process. No objections were received.
