

**BYLAW 54-2020  
A Bylaw to Amend Bylaw 70-2017**

**This bylaw amends Bylaw 70-2017 a bylaw authorizing the Council of Strathcona County to incur indebtedness by the issuance of debenture(s) for the purpose of financing the outdoor amenities and servicing of a Multi-Use Agricultural Facility**

**AS:**

The Council of Strathcona County on April 10, 2018 duly passed Bylaw 70-2017, authorizing Strathcona County to incur indebtedness in the amount of \$14,499,000 for the purpose of financing the outdoor amenities and servicing of a Multi-Use Agricultural Facility for a period not to exceed twenty-five (25) years.

It has now been determined that the total cost of the outdoor amenities and servicing for the Multi-Use Agricultural Facility project is \$28,210,000. The borrowing authority will therefore be increased by \$10,890,000 from \$14,499,000 to \$25,389,000.

- 3 Deleting the figure to be contributed by debenture(s) of \$14,499,000 as it appears and substituting the figure \$25,389,000.
- 4 Deleting the figure representing total costs of \$16,110,000 as it appears and substituting the figure \$28,210,000.
- 5 Deleting the words "FOURTEEN MILLION FOUR HUNDRED NINETY NINE DOLLARS" in section one of the bylaw and replacing them with " "TWENTY-FIVE MILLION THREE HUNDRED EIGHT-NINE THOUSAND DOLLARS."
- 6 Deleting the paragraph, "The principal amount of the outstanding debt of Strathcona County at December 31, 2016 is \$171,804,915 and no part of the principal or interest is in arrears." and substituting the paragraph "The principal amount of the outstanding debt of Strathcona County at December 31, 2019 is \$162,181,578 and no part of the principal or interest is in arrears."
