# 1.0 BACKGROUND

## 1.1 PURPOSE OF APPLICATION

Mattamy Homes has proposed an amendment to the Cambrian Crossing Area Structure Plan (ASP) and North of Yellowhead Area Concept Plan (ACP) to facilitate the future development of their lands within Cambrian Crossing. It is anticipated that the proposed amendment will be presented to Strathcona County Council in the Spring of 2021.

Prior to the proposed amendments to the North of Yellowhead ACP and the Cambrian Crossing ASP moving forward to Council for consideration, consultation was undertaken with surrounding landowners and members of the community.

This report is intended to provide an overview of the consultation process and the feedback received on the proposed amendments.

## 1.2 CONSULTATION METHODS

### 1.2.1 2014 CONSULTATION – PUBLIC MEETING

Mattamy Homes and Stantec Consulting Ltd. hosted a public information session in February 2014. The purpose of the meeting was to explain to residents and landowners the overall vision for the proposed community, provide an overview of the proposed amendment, and explain the next steps of the amendment process and how they can continue to be involved in the process. The Public Information Meeting included presentation boards to illustrate the proposed amendment, a presentation from Stantec and Mattamy, and a Q&A period about the proposed amendment. Approximately 18 people attended the public information meeting. No comments or feedback forms were returned.

#### 1.2.2 PROJECT WEBSITE & SURVEY

Due to COVID – 19 a public meeting was not held to present the final version of the proposed amendments to members of the public. Rather, a project website was developed to provide information on the proposed amendments, the amendment process, and application timelines (screenshots of the project website have been included in **Appendix A** on page 7). Additionally, a link to an electronic survey was provided for on the website and asked members of the public to provide their respective feedback on the proposed amendments. The project website and survey were open from March 15, 2021 to March 29, 2021.

# **Previous Public Meeting**

The amendment application proponent hosted a public information session in February 2014. The purpose of the meeting was to explain to residents and landowners the overall vision for the proposed community, provide an overview of the proposed amendment, and explain the next steps of the amendment process and how they can continue to be involved in the process. The Public Information Meeting included presentation boards to illustrate the proposed amendment, a presentation from Stantec and Mattamy, and a Q&A period about the proposed amendment. Approximately 18 people attended the public information meeting. No comments or feedback forms were returned.

## Next Steps

If the proposed amendments are approved by Strathcona County's Council, rezoning and subdivision applications will be submitted to the County for the first stage of development. The first stage of development is expected to be in the northeastern portion of the plan amendment area. The preparation of land for development will occur within the first stage of development which will include grading, utility servicing, and roadways.

Mattamy Homes anticipates that the construction of homes will tentatively begin in 2022 with occupancy set for 2023.

# **Project Background**

### **Planning Governance**

#### What is the governance structure for planning in Strathcona County?

Planning within Strathcona County is guided by the planning governance hierarchy outlined within the adjacent figure.

#### What is an Area Concept Plan and an Area Structure Plan?

Developing communities within Strathcona County are guided by both an Area Concept Plan (ACP) and an Area Structure Plan (ASP). These plans provide a land use and servicing framework for communities by designating where residential, commercial, institutional, and recreational development will be located, how many people are expected to live and work within a community, and how a community will be staged over time.

An ACP is a high-level plan that outlines broad locations of various land uses as well as major infrastructure such as arterial roadways and can be comprised of several ASPs. The ASPs provide more granular details regarding land use designations within a neighbourhood.

#### Why are amendments to these plans needed?

Amendments to ACPs and ASPs are common. As ACPs and ASPs cover large areas of land, the complete development of these plans typically take place over the course of 20 to 30 years. During this development period, development trends and consumer preferences may change to necessitate amendments to the plans to reflect these new market conditions.



# Location



The Cambrian Crossing Area Structure Plan encompasses approximately 365 hectares of land, located at the north-western corner of Highway 16 and Highway 21. The plan area abuts the C.N.R. railway line to the south, the realigned Township Road 534 forms the northern boundary, and Range Road 231/Clover Bar Road forms the western boundary.


The Cambrian Crossing ASP was originally approved by Strathcona County's Council in 2011. Several amendments to the document have occurred since that time, with the most recent being in the winter of 2020. This proposed amendment would result in adjustments to the following land uses that are already included within the ASP:

- Revised school / park location
- · Revised neighbourhood park locations
- Revised stormwater management pond locations
- Enhanced pedestrian connections
- Establishment of neighbourhood focal points
- Better integration of natural features (Oldman Creek, crown-claimed wetland, and tree stand into the community design)
- Creation of a centrally located institutional mixed-use site


