### **Report Purpose**

## Report

Strathcona County is one of the safest communities in Alberta and we are facing changing circumstances due to the global pandemic. Social isolation, employment interruptions and financial pressures associated with the pandemic have the potential to increase risk factors for mental health challenges, substance abuse, violence and criminal behaviour. As a community we can be proactive as we respond in this new context.

Community partners, the RCMP and administration are in the early stages of developing a Community Safety and Well-Being Plan (CSWB).

- A Steering Committee of senior community leaders is giving guidance and direction to the actions required in CSWB planning.
- The Social Framework Leadership Table is supporting the initiative through an advisory role.

The County has procured the Canadian Municipal Network on Crime Prevention as a mentor to the Steering Committee by providing strategic advice, expertise and connections to municipalities across Canada.

Two new key members have joined the Steering Committee. We welcome Superintendent Dale Kendall, Officer in Charge, Strathcona County Detachment and Tom Sutton, Director, RCMP Supports and Enforcement Services.
