Deputy Mayor Parks called the meeting to order at 1:00 p.m. with the following acknowledgement:

Today, I am on Treaty Six Territory and the homeland of the Métis Nation of Alberta, Region Four. As such, we recognize there are Indigenous Peoples who walk amongst us who have been tragically affected by residential schools. As the remains of 215 children were uncovered in Kamloops, we realize had it not been for residential schools these children would now be Elders, Knowledge Keepers, and change makers in our communities; but they never came home. This is not just history but a legacy of wrong doings that are still prevalent today. We realize, that as we mourn, we must not be satisfied by the current systems but push to implement the Truth and Reconciliations Calls to Action.

All those in attendance took 215 seconds (3 minutes 35 seconds) to mourn the 215 Indigenous children and the others that never came home.
