Agriculture Master Plan: Background

The Agriculture Master Plan is a made-in Strathcona County plan that fits the needs of our unique community.

The plan addresses two questions:

- what is the future of agriculture in Strathcona County?
- what strategies and policies are required to enable this future to be realized?

The Implementation Strategy outlines how Strathcona County intends to explore the recommendations in the Agriculture Master Plan. Implementation of the Agriculture Master Plan will involve evaluation of five key strategy areas.



Next Steps:

• Awaiting the completion of the Edmonton Metropolitan Region Board's Regional Agriculture Master Plan (RAMP), in order to incorporate direction and reduce overlap





Agricultural Land Use and Development Strategy

Completed implementation of draft strategy:

- Incorporation and expansion of agricultural land use opportunities in Municipal Development Plan update 2016
- Design and development standards
- Agricultural Impact Assessments (as outlined in Regional Growth Plan)
- RAMP development





Agriculture and Food Sector Development Strategy

PENDING

This strategy area is about attracting new diverse enterprises and building a support network to encourage current agriculture and food endeavors within Strathcona County.

Examples of topics that may be explored include:

- expansion of educational programming relating to agriculture
- development of local food opportunities and the equine sector
- formation of Agriculture and Food Leadership Institute to further the interests of agriculture





Agritourism Strategy

The recently accepted Tourism Strategy (2020) has a strong agritourism component, listed as a key product development stream.

Agritourism refers to the opportunity to discover agriculture through experiential education.

Examples of topics that may be explored further include:

- connecting with current agritourism operators
- open market opportunities


Mission:
