Report

Strathcona County continues to follow the COVID-19 provincial guidance. The Alberta government's 'Open for Summer Plan' provides a three-stage road map to lifting health restrictions based on criteria outlined by the Minister of Health.

At the front lines SCEMA is receiving and adapting to the Alberta Health announcements and recommended changes while tracking developments on testing, vaccine rollout and distribution, and tracking and reporting of COVID cases and variants. SCEMA applies this information and guidance to support local community services, including resumption of recreation activities, service delivery, and social supports to best support our staff, citizens and businesses with the end goal of re-opening our province and community safely.
