

COVID-19 Status update for November 30, 2021**Report Purpose**

Report

Strathcona County Council approved Bylaw 53-2021 on September 1, 2021. This bylaw went into effect on September 10, 2021. The Chief Medical Officer of Health (CMOH) Order 40-2021 went into effect as of September 3, 2021 which outlined province-wide masking requirements. The province has since declared a Public Health State of Emergency on September 15, 2021 and Order 44-2021 (September 23, 2021) has replaced Order 40-2021 and continues to outline public health measures today. Strathcona County continues to follow the COVID-19 provincial guidance. Public health restrictions were put in place to reduce impacts of COVID-19 on the health care system. Strathcona County Council approved entering into the Restrictions Exemption Program (REP). On September 20, 2021 the REP was implemented to support the expansion of resident in-scope activities at all County facilities.

Masking remains mandatory in Strathcona County through the application of Bylaw 53-2021 and CMOH Order 44-2021. CMOH Order 44-2021 includes additional restrictions including physical distancing, work from home and gathering restrictions. The Temporary Mandatory Face Coverings Bylaw 53-2021 for Strathcona County expires on December 31, 2021. An approach to follow a single provincial directive within the community is recommended.

SCEMA continues to monitor local COVID-19 infection and vaccination rates and the impacts of provincial orders within our community. This continued and consistent monitoring and application of existing measures will be used to support the safe continuation of services and provide social supports. Recommendations will continue to be brought forward that best support our staff, residents, and local business while holding community safety paramount.
