

Colchester Community League Edible Forest

Colchester Community League strives to bring light and life into the community by getting families involved in events at the hall that are unique and fun for all. We will give the community a place to celebrate, laugh, learn and grow together.

Colchester Community League would like to start an Edible Forest and walking trails on the south side of the 8 acre parcel at Colchester hall. The project would be multi-year and would kick off in the spring of 2022 with site layout and planning. As part of the overall project we would also like to place shade trees near the community hall and playground.

Colchester Community League needs a letter of support for our edible trial and shade tree project at Colchester Hall in order to support an application to the Community Facility Enhancement Program (CFEP), Peavey Mart or other funding sources.

The garden groups, intent is to create a walking trail on the south portion of the community hall grounds, Figure 1, and wants to make sure its installation and ongoing operation will not cause maintenance problems for the Strathcona County grounds crew.

The Edible Forest will consist of fruits trees, canes and shrubs which are safe for consumption and free for the taking. The selection of plant species include, apples, plums, cherries, and Haskap to name a few. We would also like to incorporate a wild area for choke cherries, cranberries pin cherries, gooseberry and saskatoons which grow well in our area.

Edible Forest makeup is an essential part of the development of agricultural ecosystems intended to be sustainable and self-sufficient. Local food supplies are important from the perspective of security, climate change and ensuring that lower income families have access to high quality fruits and vegetables.

An Edible Forest is very important as it provides an avenue for anybody who loves gardening to develop a meaningful connection with nature through a holistic design system integrating food, water, shelter energy and waste system into the design of sustainable human habitats.

Our group feel this is a worthwhile project, as it can provide a rich cultural opportunity to plant, harvest, learn and grow food together and all these activities are "Community-Building". We currently have about a dozen members of the gardening group and to attract new community league members and volunteers with an interest in gardening as the project progresses.

It is more important than ever to bring people together in a community setting given the isolation with the pandemic, Ukraine and food prices soaring out of control. An Edible Forest is a marvelous way for people to get outdoors and meet while still maintaining any necessary physical distancing.

The project budget is currently \$42,000.00 over a two-year period as shown below. We currently have the support of the community league as well as the Colchester and District Agricultural Society which has pledged \$10,000 to be used as matching for the Community Initiatives Program. The group will submit an application together to Peavey Mart (due May 31).

We will be starting with a basic or a simple design and as we grow in knowledge, we will be able to incorporate and add different elements over time. The possibility are endless and everyone is welcome to provide input and help in this project. The starting point will be the layout of the site with approximate species placement as shown in Figures 2 through 5. Ultimately the beds will be covered with mulch and wide grass trails will be placed between beds to enable grass cutting. Weather proof signs will be placed near each different species of tree/fruit bush to enable easy identification.




Figure 3 Bed planting with mixture of fruit and berry bearing shrubs

The total budget for the project is about \$42,000 and we have support of the Colchester and District Agricultural Society (\$10,000), Colchester Community League (2000) and Prairie Gardens (horticulturist time). We are applying to the Community Initiatives Program and Peavey Mart for the balance of the required funding but would love to kick off this spring with garden layout and identification of appropriate plant species/culitvars and would really appreciate your support. We have enlisted volunteer support of the community league, the scout troop that meets at the hall, the local 4H group and local residents for the planting and bed preparation.
