



Bylaw 31-2022 map amendment to Land Use Bylaw 6-2015 (Ward 4)

Legal Description: SW 24-53-23-W4

Location: South of Township Road 534 and east of Range Road 231 **From:** AD – Agriculture: Future Development zoning district

To: PU – Public Utilities zoning district

Report Purpose

To provide information to Council to make decisions on first, second and third readings of a proposed bylaw that amends Land Use Bylaw 6-2015 by rezoning approximately 2.41 hectares (5.97 acres) of land within a portion of the SW 24-53-23-W4 from AD – Agriculture: Future Development zoning district to PU – Public Utilities zoning district in accordance with the Cambrian Crossing Area Structure Plan.

Recommendations

- 1. THAT Bylaw 31-2022, a bylaw that amends Land Use Bylaw 6-2015 by rezoning approximately 2.41 hectares (5.97 acres) of land within the SW-24-53-23-W4, be given first reading.
