# **Our Prioritized Strategic Goals**

Goal 1 - Build strong communities to support the diverse needs of residents

### Report

The function of the Art Collection Advisory Committee is to guide selection of art acquisitions for Strathcona County's Art Collection through the development of the guidelines and criteria. The selection panel which has both Advisory Committee members and local artists recommend the pieces to be added to the permanent collection.

This year, 65 artists submitted artwork for a total of 141 artworks from adults. In the youth category there were 53 artworks submitted by 46 students at the Art Society of Strathcona County's "High School Student Art Competition, Show and Sale" at the Red Barn. 10 artworks were chosen by the Art Society's jury for monetary awards and will be on loan to Strathcona County for one year.

The recommended purchases for the 2022 Annual Art Acquisition program totals \$20,480. \$11,980 will be provided through the operational budget for 2022. An additional \$8,500 from the Cultural Reserve will be utilized for the purchase of culturally diverse artwork for the Art Collection. This year the Cultural Reserve will purchase artwork from First Nations and Métis artists.

## **Council and Committee History**

October 20, 1987 Council approved the Terms of Reference for the Strathcona County

Permanent Art Collection Committee (Resolution #1097/87). The Committee has made recommendations annually for the purchase of

artworks.

July 8, 2014 Council approved the Strathcona County Public Art Plan. Thereafter, the

Permanent Art Collection Committee is known as the Art Collection

Advisory Committee.
