Our complex put up Christmas lights a few years ago on a 50 ft. spruce tree in the middle of our seniors' neighborhood. Unfortunately, we did this project cheaply and without really knowing what we were doing, The strings are now broken and the lights are in desperate need of repair.

After lots of research (and guidance from your Parks and Recreation department), we are looking at getting more permanent lights put on this tree. We will have them professionally installed, with a commercial grade of lights, and hopefully it will last for many years to come.
