

# Calls to Action Plan Overview:

3) We call upon all levels of government to fully implement Jordan's Principle.

## Completed Actions

- Initial research on the call to action and principle has been completed
- Staff participated in Indigenous awareness programs which covered a variety of topics including Jordan's Principle

# Calls to Action Plan Overview:

#40) We call on all levels of government, in collaboration with Aboriginal people, to create adequately funded and accessible Aboriginal-specific victim programs and services with appropriate evaluation mechanisms.

## Completed Actions

- Victim Services staff have participated in the RCMP & Enforcement Services Indigenous Canadians and Reconciliation Orientation course

# Calls to Action Plan Overview:

#43) We call upon federal, provincial, territorial, and municipal governments to fully adopt and implement the United Nations Declaration on the Rights of Indigenous Peoples as the framework for reconciliation.

## Completed Actions

- Legislative and Legal Services completed a detailed analysis of UNDRIP to understand the legal implications and identified potential next steps

# Calls to Action Plan Overview:

#47) We call upon federal, provincial, territorial, and municipal governments to repudiate concepts used to justify European sovereignty over Indigenous peoples and lands, such as the Doctrine of Discovery and terra nullius, and to reform those laws, government policies, and litigation strategies that continue to rely on such concepts.

## Completed Actions

- Indigenous days of significance like National Indigenous Peoples Day have been recognized by Council and the County hosted related events
- Many staff have been given September 30th off to engage in the National Day for Truth and Reconciliation

# Calls to Action Plan Overview:

#57) We call upon federal, provincial, territorial, and municipal governments to provide education to public servants on the history of Aboriginal peoples, including the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, Indigenous law, and Aboriginal-Crown relations. This will require skills-based training in intercultural competency, conflict resolution, human rights, and anti-racism.

## Completed Actions

- SLT took part in an introductory Indigenous Awareness workshop
- Council attended a Métis 101 session at Métis Crossing
- RCMP & Enforcement Services took part in Indigenous cultural awareness training
- County Lawyers completed the Law Society of Alberta training
- FCS organized a territorial acknowledgement workshop
- Established an internal resource website for staff

Short-Term	Medium-Term	Long-Term
- Pilot and soft launch the Indigenous Peoples, History, and Intercultural Relations Training	- Roll out the Indigenous Peoples, History, and Intercultural Relations Training to all staff  - Identify added experiential learning opportunities for County staff	- Explore opportunities for more advanced training for interested staff and leadership

# Calls to Action Plan Overview:

#75) We call upon the federal government to work with provincial, territorial, and municipal governments, churches, Aboriginal communities, former residential school students, and current landowners to develop and implement strategies and procedures for the ongoing identification, documentation, maintenance, commemoration and protection of residential school cemeteries or other sites at which residential school children were buried. This is to include the provision of appropriate memorial ceremonies and commemorative markers to honor the deceased children.

## Completed Actions

- Struck an advisory circle of Indigenous artists and an Elder to define project approach and scope
- Issued a call to artists and identified 2 artists to install temporary visual art projects

# Calls to Action Plan Overview:

#77) We call upon provincial, territorial, municipal and community archives to work collaboratively with the National Centre for Truth and Reconciliation (NCTR) to identify and collect copies of all records relevant to the history and legacy of the residential school system, and to provide these to the NCTR.

## Completed Actions

- Conducted an initial scan of County records and did not identify any relevant records
- Contacted the NCTR to understand more specifically what records they collect

# Calls to Action Plan Overview:

#87) We call upon all levels of government, in collaboration with Aboriginal peoples, sports halls of fame, and other relevant organizations, to provide public education that tells the national story of Aboriginal athletes in history.


#88) We call upon all levels of government to take action to ensure long-term Aboriginal athlete development and growth, and continued support for the North American Indigenous Games, including funding to host the games and for provincial and territorial team preparation and travel.

<ul style="list-style-type: none"> <li>- Cultural services will identify influential Indigenous athletes to highlight</li> <li>- Establish relationships with Indigenous sports organizations like the Indigenous Sports Council of Alberta</li> <li>- Communicate current funding opportunities for athletes</li> </ul>	<ul style="list-style-type: none"> <li>- Identify athletes or other builders to nominate for the Millennium Place Sports Wall of Recognition</li> <li>- Explore granting opportunities for competitive Indigenous athletes</li> </ul>	<ul style="list-style-type: none"> <li>- Through the broader history project, explore the history of Indigenous athletes in the County</li> <li>- Continue to highlight Indigenous athletes and others in sport when possible</li> <li>- Identify opportunities to align Indigenous sport initiatives with the Sport and Tourism Strategy</li> <li>- Explore hosting the North American Indigenous Games</li> </ul>

# Additional Initiatives

- Administrative Indigenous Advisory Committee
- Relationship development with Indigenous communities and organizations
- Engagement with Indigenous communities on projects like the the Strathcona County Regional Park Master Plan, the Edmonton-Strathcona County Footbridge, and the Astotin Creek Resiliency Study.
- Celebrations of Indigenous culture at Canada Day, National Indigenous Peoples Day, and NDTR
- Increasing Indigenous components in County programming, including in Gallery 501 and Festival Place
- Land acknowledgement workshops and ceremonies across departments
