

Changes to the 2022 Meeting Dates Schedule - Budget Process

Report Purpose

To seek Council approval on changes to upcoming Council budget meetings dates and to provide an overview of the budget process.

Recommendation

- 1. THAT the following changes to the multi-day Council budget meeting be approved:
 - Cancel October 27, 2022
 - Cancel November 1, 2022
 - Add November 17, 2022 from 1:30 p.m. 4:45 p.m.
 - Change the start time for November 18, 2022 to 1:00 p.m.
 - Add November 21, 2022 with a start time of 9:00 a.m.
 - Add November 28, 2022 with a start time of 9:00 a.m.
 - Add December 5, 2022 with a start time of 9:00 a.m.
- 2. THAT a non-statutory public hearing on the development of the Multi-Year Budget be held on September 27, 2022 at 5:00 p.m.
- 3. THAT a non-statutory public hearing on the recommended Multi-Year Budget be held on November 21, 2022 at 5:00 p.m.

Governance Requirement

Report

Changes to the 2022 meeting dates schedule are being recommended to accommodate scheduling conflicts for members of Council and to facilitate the budget process. The proposed meeting schedule includes the addition of two non-statutory public hearings: the first to hear from the public before final development of the budget, and the second to consider feedback on the recommended budget.

If these changes are approved by Council, the schedule will be as follows:

The process outlined above is similar to past practice, with the addition of the preliminary non-statutory public hearing before the recommended budget is finalized. Council will receive a closed session introduction and orientation to the recommended budget on November 3. The budget documents will be made available to the public on November 16 when Administration begins the open session budget presentation.

Members of Council with have opportunities to ask questions throughout the process and will also be able to identify "Flagged Items". Flagged Items are requests for information and future discussion that are used if an issue raised by a Councillor is deemed by Council motion to be critical for budget approval. These items are voted on, and if passed, the item will be flagged and will come back to Council for discussion and direction prior to budget approval.

The proposed schedule includes three days for budget deliberations after the recommended multi-year budget has been presented. This is the point at which Council move and pass amendments and debate the recommended budget prior to approval.

March 8, 2022 Priorities Committee was provided with an update on public

engagement options for the upcoming budget cycle.
