RCMP & Enforcement Services		The RCMP and Enforcement Services has not issued a bicycle infraction ticket in the last two years (2021 and 2022). There is no bylaw in Strathcona County requiring the use of a bicycle helmet. The Alberta Traffic Safety Act does, however, require riders under the age of 18 to wear an approved helmet when operating a bicycle on roadways. The RCMP and Peace Officers have taken an educational approach to bicycle safety rather than issuing fines to youth when interacting with riders. On patrol and during the department's Bike Rodeo on May 14, 2022, the Detachment's Bike Patrol Unit actively engage members of the public to educate riders on bicycle safety. To encourage compliance through positive reinforcement, throughout 2022 officers issued approximately 100 positive tickets to young people observed wearing helmets while riding. In partnership with Family Community Services, the department is also prepared to provide a limited number of helmets to young people found during routine patrols unable to afford this important safety device.	9/13/2022	9/23/2022	9/21/2022	Complete
