This was our third annual fair, interrupted for two years by Covid, and it was very well attended. We estimate we had 150 adults and 150 children attend and received very positive feedback from the community.

We feel the fair is very important to the Antler Lake Uncas Community as it fosters community growth and togetherness and provides cost-effective entertainment to our residents.

Most of our entertainment (bouncy castles, live music, petting zoo, games, etc.) was free to all attending. We did charge for food and had a beer tent, but these sales did not cover the cost of the capital and other expenses we incurred. We also did not know how many people would attend so had trouble estimating the amount of perishable food to purchase.

It is our intention to eventually reach a point where our fair will be self-sustaining, but in the meantime, we would very much appreciate the County's help in covering the expenses for our fair so we can continue to provide these events to the community in the future.
