Report

The outcome for the Recreation and Culture program, outlined in the 2023-26 Business Plan is to increase the quality of life through the engagement of people in active living pursuits and in the protection and enrichment of customs, traditions and values of society and the community. Recreation, Parks and Culture generates meaningful opportunities that contribute to individual and community well-being, provide welcoming places and offer creative and active lifestyle choices. Linkages the County has regarding heritage, history, arts, culture and recreation include:

- Culture Heritage focus on preserving the history, heritage, customs, and traditions
 of Strathcona County. This includes music, language, art, expression, traditions, and
 community experiences.
- Recreation and Culture Delivery provides services and programming for members
 of the public to partake in recreational, cultural and leisure activities. This includes
 programs, events, and activities that targets a variety of ages, locations, skill levels,
 and activity types.
- Recreation and Culture Facilities provide individuals or groups access to facility space for recreation and culture purposes, including both indoor and outdoor facilities. This includes booking facilities, as well as accessing unstructured or general use amenities.

The Council approved Arts, Culture and Heritage Community Investment Program supports Strathcona County-based community non-profit arts, culture and heritage organizations to deliver cultural activities, services and programs. Since its creation the Arts, Culture and Heritage Community Investment Program has supported 35 unique groups. The program has been well utilized since its implementation and the majority of eligible projects are funded. Post-COVID the program is seeing a higher volume of applicants. Recreation, Parks and Culture also offers a large-scale community event grant as well as a Community Recreation Event Sport Tourism grant for eligible groups.

Strathcona County has a vibrant culture community with experiences and programs supported through various delivery methods. There are numerous groups delivering meaningful opportunities. We were not able to invite all groups to Community Presentation Day due to time constraints.
