## The Friends of Strathcona County Library Society

#### **Our Vision**

All residents of Strathcona County will have the opportunity to contribute to the continued development of the Strathcona County Library as an integral part of the community, enhancing the lives and well-being of everyone.

#### **Our Mission**

The Friends of Strathcona County Library shall be a society of persons interested in the welfare of the Strathcona County Library. The society shall raise funds to meet specific library needs, promote library services and advocate on behalf of the library.

## History of the Friends of Strathcona County Library Society

In 1972, a group of Strathcona County residents decided the community of 26,000 should establish its own library and petitioned the County Council for legal sanction to appoint a library board. On February 14, 1977, the County of Strathcona Municipal Library welcomed the community to its home in the newly constructed County Hall in Sherwood Park.

In 1989, it became apparent that there was interest in forming a "Friends of the Library" group, as other public libraries have, to raise public awareness of Strathcona County Library and to raise funds to support library projects.

On July 7, 1992, a Proposal for the Formation of the Friends of Strathcona County Library was discussed by the Library Board along with interested community volunteers. The proposed primary focus was to be fundraising, public relations and advocacy. The timing was thought to be right because of the opening of the new library facility on the lower level of the Sherwood Park Mall (the library was previously located in the Strathcona County Hall). As well, in the mid-1990s, municipal funding from the Provincial Government was decreasing and there was a freeze on direct provincial funding to public libraries, identifying a need for alternative sources of revenue.

On April 21, 1993, an organizational meeting was held, where the Constitution and Bylaws of the Friends of the Strathcona County Library were adopted, and the election of officers took place.

On May 13, 1993, the Friends of Strathcona County Library Society was incorporated under the Alberta Societies Act. In the application to form the not-for-profit society, the objectives of the Society were laid out:

- Aid in providing funds to meet special library needs
- Promote library services
- Advocate on behalf of the County of Strathcona Municipal Library the name of the municipality changed to Strathcona County in 1995

The Friends of Strathcona County Library is governed by a Board of volunteers of wide-ranging interests and backgrounds. The Board is composed of up to 15 Directors, including the President, Past-President, Vice-President, Treasurer, Secretary and a representative of the Library Board. In late 2019, the Friends of Strathcona County Library had over 100 committed supporters of all ages, from children to seniors. More than 40 supporters made the extra commitment by becoming full members, including 14 Board members. The rest are committed volunteers who help out at both Friends events and library events.

Since early 2020, COVID-19 restrictions caused a slowdown of Friends activities and events, as well as volunteer/member engagement. Without having enough volunteers who were willing to take on leadership roles, Friends was in danger of folding. As a result, Wendy Saunders (current President) agreed to head a Re-engagement Team and presented a slate of officers and coordinators who formed the current Board effective May 8, 2023.
