## Property Tax Relief - Request for Hearing

Once complete, please return this form to Strathcona County's Legislative and Legal Services Department. The Legislative and Legal Services department will be in contact to set up a hearing date in front of Council.

An application for property tax relief must be presented to Council at a regular Council meeting. Council will consider the request and make a decision. In making its decision Council will consider the impact of the property tax relief on all property tax payers in the County. Presentations, deliberations, and decisions will typically be conducted in a public Council meeting.

Further information can be found in Strathcona County's *Property Tax Relief* policy, found on the County's website.

Council may consider tax relief applications that fall into one of the following categories:

Error in Fact

- only applicable to objective and material errors such as building characteristics or tax-exempt status, but does not include subjective property valuation assessment matters
- only available for the current or prior taxation year

Tax Exempt Properties While Under Construction

- request must be made by a tax-exempt organization
- construction must currently be in progress on facilities on the property that will be used for a taxexempt purpose upon completion of the construction
- only applies to up to three consecutive taxation years

Compassionate Grounds

- a death or critical illness in the family has made it difficult or impossible to meet the tax obligations, and a late-payment penalty was incurred as a result
- only applies to the penalty portion of the tax assessment, and only to the current taxation year

Tax relief requests that do not fall into these three categories may require additional evidence to demonstrate that granting relief will not result in an undue burden on all other property tax payers in the County. These requests may be made to Council in the "Other" category.

Council will generally not grant tax relief in the following circumstances:

- 1. Taxes imposed for the designated industrial property requisition.
- 2. Taxes or penalties relating to more than one prior taxation year.
- 3. Amounts added to the tax roll that do not relate to the annual property assessment and taxation process, including but not limited to:
  - a. charges arising from the tax recovery process;
  - b. unpaid violation tickets;
  - c. utility consumption or installation charges; or
  - d. any penalties, interests or other charges related to those amounts.

To Whom it may concern,

I was Operator/Owner of an NDT company based in Edmonton AB, Asset Integrity Management Inc. I was a 50/50 share holder with Shain Bakoks of Bakos NDT inc. located in Whitecourt AB. Asset Integrity Management (AIM) had approximately 15 full time employees Bakos had approximately 17 full time employees. Due to the down turn in the economy, that started in 2015 we had decided to merge the two companies together. This merger took place on May 01/2017. So due to the down turn in the economy we were already struggling as an NDT company in Alberta. We were at the point of not having money in the bank to make payroll and having no money to supply jobs with needed equipment or fuel. We were at an extremely stressful time when COVID struck March of 2020, it was a devastating blow. At the Time we had started talks with Rockwood a large corporation out of the USA, they own a multitude of companies including Acuren NDT. The acquisition of the company to Rockwood was complete September 04/2020. With the current economic environment (shutdown)at the time of the sale of the company, it barely covered the debt of the company, leaving me with the initial startup debt of the original company (AIM). At the time of all of this I could not get myself around completing the recertification. My head was not in a good place, with a failing company and mountains of debt.

My medical problems started around may of 2019, it started with a feeling of pain in my sciatic nerve. As the problem worsened the doctors were no help sending me for multiple tests and physical therapy. My disability was growing worse and worse with every month. Half way through 2020 we figured it out, it was a past injury creating the need for a total hip replacement, by this time I could barely walk. I was put on a waiting list for surgery, I was on crutches by the end of 2020. COVD had the hospitals working at full capacity with the loss of staff and lack of beds, the surgery wait list was growing. I was total disabled at this point on the couch, unable to move, sleep or function. I did not get into surgery until June of 2022. After a month of recovery, I was forced to go back to work on the pipeline while I was still walking with a cane, I had no choice as I was in a position to lose everything.

On my follow up appointment post surgery, we booked an appointment for my Right hip. That date was booked approximatley one year to the date, it was for July 14, 2023. for some reason, I beleave due to a bogged down system, I was bummped form my date. I am now to the point of full disability, I cant work! I have burned thrugh any savings, sold evrything we owned, and borrowed as much as we could from frends and family. we are at the end, next is lose our house. we will be forced to rent for the same price, if we can find a place with broken credit and no money for a deposit!

With the surgery I would be able to go back to work and pull out of yhis nightmare!

Plaese conciter my crys for help!! I have workrd one year in the past three due to wait times for surgery!!
