- Cost escalations on various key contracts and inventory placing upward pressure on property tax and utility rates
- Determining impacts of climate change on operations and infrastructure requirements
- Balancing maintaining our infrastructure with new growth infrastructure projects

- Exploring and promoting economic diversification opportunities in hydrogen and renewable energy sectors, value added agriculture, transportation and logistics and advanced manufacturing
- Continue to expand and enhance online application technology to streamline application processes

- Engaging and collaborating with local tourism industry to explore future tourism products
- Continue to review service levels, infrastructure investments and advocating for infrastructure development to drive future private sector investments





## **IPS Division - Efficiencies**

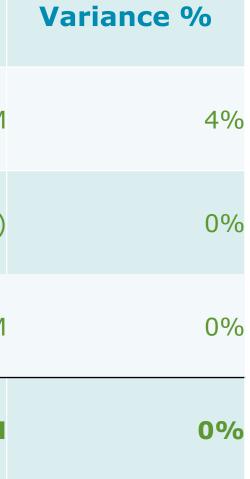
- Improvements as a result from the 2022 IPS division re-organization:
