### Report

Agricultural Service Boards have a long and rich history in Alberta. A municipal program that was established jointly with the province in 1945, our Agricultural Service Board (ASB) works to advocate for agriculture while examining policy and program details that support our agricultural community. Further, ASB's are part of a greater provincial organization that gather each year to discuss, debate, and pass resolutions.

As our organization grows, and as the legislative framework around agricultural service matures, the current Agricultural Service Board Bylaw 43-2021 and its associated procedures needs to be evaluated to support:

- the County's legislative commitments under the provincial Agricultural Service Board Act RSA 2000, c A-10
- our vision of agricultural leadership
- our participation in agricultural advocacy at the community and provincial level

<u>Goal</u>: Position an ASB that is informed by the agricultural community to participate as leaders through advocacy and a strong understanding of municipal responsibilities and programming.

<u>Recommendation</u>: That the ASB assemble as a governance committee, composed of members of Council who seek advice from subject matter experts within our agricultural community through issue-specific taskforce advisory committees of representative interested parties, and supported by:

- robust public engagement to provide valuable, targeted advice on agricultural issues
- presentations from community groups that represent the sector

<u>Next steps</u>: Create a proposed bylaw and supporting Administrative Procedures with approval being sought by Council in the fall of 2024.
