Report

The Environmental Framework supports a coordinated approach between administrative departments and external stakeholders, by enabling them to work together, leveraging people and financial resources, and responding to community needs in context of our air, water, land, biological diversity, waste, and energy. Each topic area has a clear outcome, and specific objectives identified that prioritize healthy ecosystems and set a foundation for healthy citizens.

Environmental Framework Integration Team (EFIT)

Members of EFIT are subject matter experts within our administration that are actively working within the topic areas and assist in the implementation of the Framework. The team meets quarterly to report on existing programs, plans, and policies and to review new opportunities and strategic initiatives. This helps us plan, document, and share collective efforts.

Strategic initiatives - January to December 2024

The EFIT prioritized several strategic initiatives for 2024. A brief summary of those initiated, continued and/or completed in 2024 is below:

- **Air** Hosted Clean Air Forum, Zero Emission Hydrogen Transit Bus in active service, Airshed partnerships, Tree Replacement Program
- Water Wetland Replacement Program Strathcona Regional Park proposal, stormwater management facility water quality monitoring and naturalization programs, Drought Management Plan, Outdoor Watering Survey, community engagement events
- **Land** Agriculture Master Plan substantial completion, Agriculture and Food Sector Development Strategy, Land Use Bylaw refresh, Drainage Charter, Weed Control Charter, Wildland Urban Interface park inspections, FireSmart inspections
- **Biodiversity** Bird-Friendly Community recertification, Human-Wildlife Coexistence Program, Urban Coyote Monitoring Program, Wildlife education refresh, Wild Boar Monitoring Program, Biocontrol pilot projects
