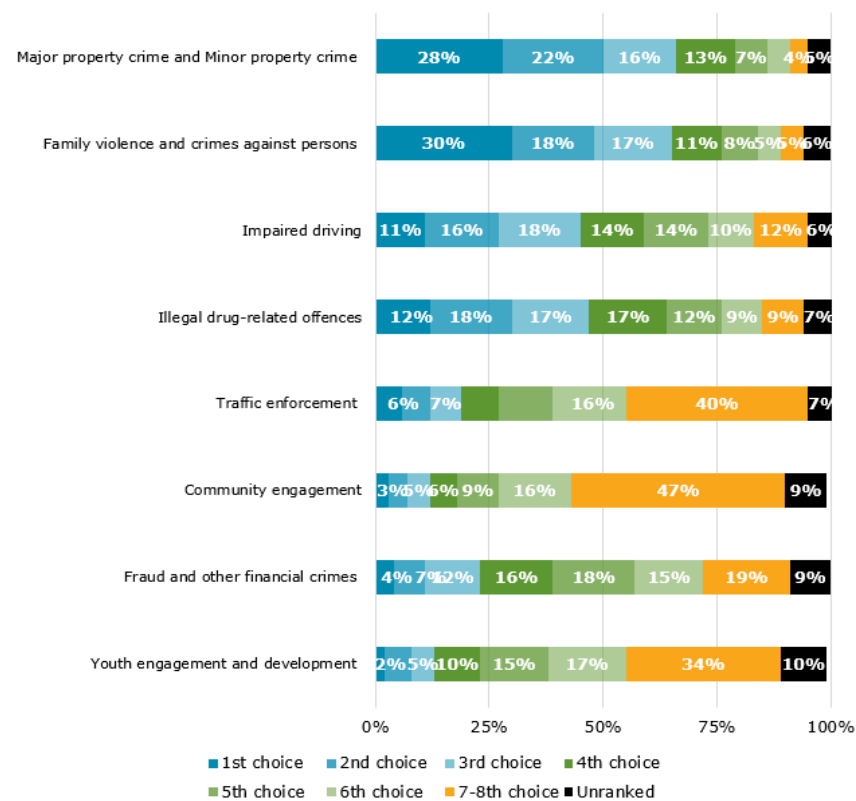

We asked respondents to rank RCMP services from highest to lowest.



RCMP Priorities in Focus

#1: Family violence and crimes against persons

70% chose as 1st, 2nd or 3rd choice (excludes unranked)

#2: Major property crime & minor property crime

69% chose as 1st, 2nd or 3rd choice (excludes unranked)

#3: Illegal drug offences – 50% (↑ 4% YoY)

#4: Impaired Driving – 48% (↑ 3% YoY)

#5: Fraud and other financial crimes – 25% (↓ 2% YoY)

#6: Traffic enforcement – 19% (↓ 1% YoY)

#7: Youth engagement and development – 15% (↑ 3% YoY)

#8: Community engagement – 13% (↑ 3% YoY)

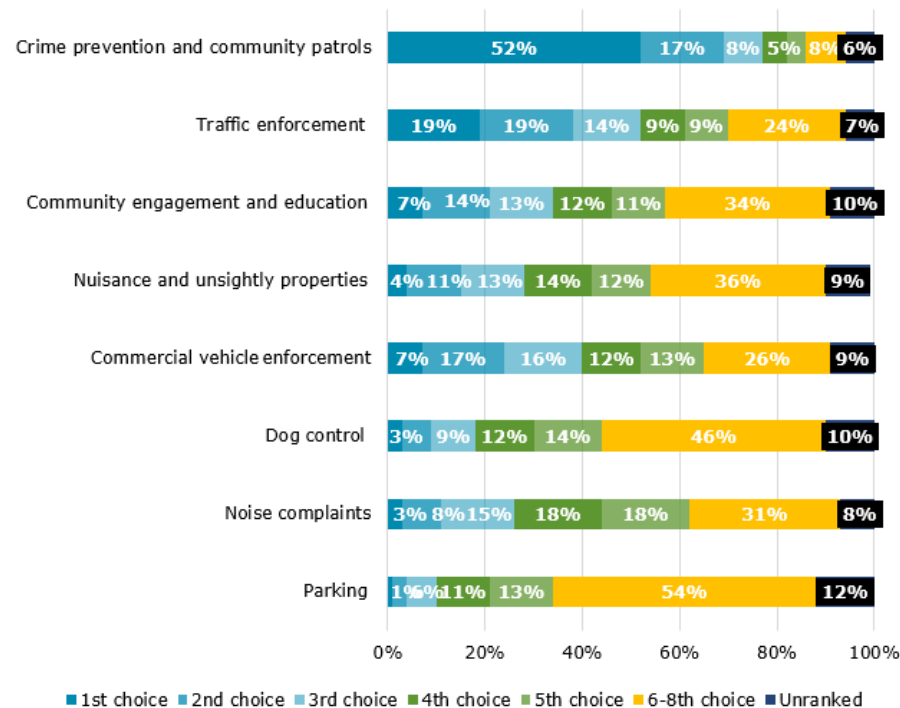




2025 Annual Performance Plan Survey Results – Enforcement Services

Enforcement Services Priorities

We asked respondents to rank the services provided by Community Peace Officers highest priority to lowest.



Enforcement Services Priorities in Focus

#1: Crime prevention and Community Patrols

82% chose as 1st, 2nd or 3rd choice (excludes unranked)

#2: Traffic enforcement

55% chose as 1st, 2nd or 3rd choice

#3: Commercial vehicle enforcement – 44% (↑3% change YoY)

#4: Community engagement – 37% (↑6% change YoY)

#5: Nuisance – 31% (↑2% change YoY)

#6: Noise – 28% (↓ 5% change YoY)

#7: Dog control – 20% (↑2% change YoY)

#8: Parking – 12% (↓ 2% change YoY)
